Meeting was called to order by Judge Royce Smith. Brother Clarence Howell led the opening prayer.

Minutes of the last meeting were read and approved. Commissioner McGee made the motion, seconded by Commissioner Smith, to approve the minutes. All voted for.

Commissioner Cox made a motion, seconded by Commissioner McGee, to approve monthly reports from J. P. # 1 thru 5, County Clerk, and District Clerk. Motion carried.




There being no further business, Commissioner McGee made a motion, seconded by Commissioner Smith, that meeting adjourn. Motion carried.


