Monday, January 9, 1989, the Honorable Commissioners' Court met in regular session at 8:30 Å. M., with the following members present:

Meeting was called to order by Judge Royce Smith, with Brother Clarence Howell leading the opening prayer.

Minutes of the last meeting were read by County Clerk, Nadine Gary.

Judge Smith informed the Court someone from the Forest Service had contacted him concerning the Hyden Road near Yellowpine, in Precinct 2. He said there is no record in their files stating this was ever a County Road. After some discussion, the Court agreed/to check into obtaining an easement from the Forest Service on this road.

Monthly bills were inspected, and made ready for payment. Commissioner McGee made a motion, seconded by Commissioner Cox, to approve payment of accounts and salaries. Motion carried

Commissioner McGee made a motion, seconded by Commissioner Cox, to approve monthly reports. Motion carried. Reports presented were from the County Treasurer, J. P. # 1 and 3, County Clerk and District Clerk.

The County Treasurer reported she has received the Forest Service check in the amount of \$445,110.29. One half of this amount goes to the schools in the county, with the county receiving \$222,555.14. Commissioner McGee made a motion, seconded by Commissioner Conn to approve the division of this money. "See attached exhibit."

Commissioner McGee made a motion, seconded by Commissioner McDaniel, to make a Time Warrant for \$5,000.00 for the purchaseof a five acre tract of land south of Pineland in Precinct 2. All voted for. This land is purchased from Temple-Inland Forest Products Corporation, and is to be used as a solid waste disposal site.

Mrs. Geneva Hignite from Sam Rayburn Estates met with the court thanking them for the work they have done on their road; but said still more needs to be done. No action was taken by the court.

Selecting the Salary Grievance Committee was posponed until our next meeting.

Judge Smith presented a list of names for the Sabine County Historical Committee. Commissioner Cox made a motion, seconded by Commissioner Conn, to approve this list. Motion carried. List attached.

Motion was made by Commissioner McGee, seconded by Commissioner McDaniel, to advertise for bids for the County Depository. Motion carried. Bid opening will be February 13, at 9:00 A. M.

Commissioner McGee made a motion, seconded by Commissioner Conn, that meeting adjourn. Motion carried
