Meeting was called to order by Judge Royce Smith.


Minutes of the last meeting will be read at our next regular meeting.





Employee parking around the square was discussed, and the Court asked all county employees to park on the jail parking lot except on rainy days.


Commissioner McGee made a motion, seconded by Commissioner Cox, that meeting adjourn. All voted for.
