Commissioner McDaniel had reported to Judge Royce Smith he would be unable to attend.


Meeting was called to order by Judge Smith.


Commissioner Billy McGee made a motion, seconded by Commissioner Chester Cox, to renew time warrant for Prct. 2, by paying interest, and renew the principal for one year. Principal due is \$31,350.00; 6% interest on this amount is \$1,880.99. Motion carried.


Victor Cain, with Texas Department of Health, Region 7, met with the Court to discuss Sanitary Land Fills. He informed the Court that they may pass a resolution stating requests from the State of Texas for the right of Sabine County to issue permits regarding County private sewer facilities. This resolution should be passed on or before September 1. There will be an installer school for certification in Tyler sometime in September. Counties will be notified of the date.

When asked about precedures for closing pits, Mr. Cain explained we would notify the Department of Health, cover them, and plant grass over them. The department of Health will check the covered pits. If pits are closed before Federal Regulations go into effect, the County is responsible for 5 years. If they are closed after regulations go into effect, we will be responsible for 30 years. He also said we have approximately 18 months before Federal Regulations take effect.


