

Thursday, May 18, 1989, the Honorable Commissioners' Court met in a called session at 8:30 A. M., with the following members present:

Meeting was called to order by Judge Royce Smith.

Judge Smith stated this meeting was called to start hearing process for issuing permits and inspecting septic tanks. We must have hearings in three consecutive court meetings. They should be no later than July 26, or possibly June 26th.

Duane Husband met with the Court representing Sabine River Authority. A question and answer session followed concerning septic tank systems. Sabine River Authority deals with the contractors rather than the individual; and the tank sizes are set by the state, according to the size of home or buildings. Mr. Husband said he can have cost figures within from 2 to 3 weeks. Commissioner McDaniel asked for a letter from Sabine River Authority stating these costs.

Others present for this meeting were Odie L. Morrison, Vincent Sherlock, and Will Smith.

Judge Smith reported he is still working on our group health insurance renewal, but at this time, still has only one bid, which is from Hillhouse Associates.

Tax Assessor/Collector, Diane Husband, met with the Court asking that they pay her deputies for keeping her office open during the City, School, and Hospital elections. After some discussion, Commissioner McDaniel made a motion, seconded by Commissioner Conn, to honor this request. Motion carried.

A discussion followed over whether or not county employees should be paid overtime, or given comp time. No ruling was made on this.

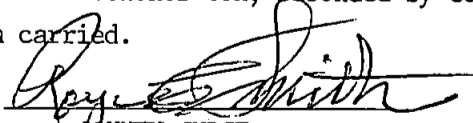
Mrs. Husband reported she will be attending a Tax Seminar in Beaumont in June, and plans for her deputies to take turns going, one each day, and they will need to use the County car. The court found no problem with this, but asked that after each trip that anyone using the car have it serviced and filled with gas, so it will be ready for the next person. A decision will be made later as to what service station we will be using.


Commissioner Cox made a motion, seconded by Commissioner McDaniel, that we issue Mrs. Husband a check for \$237.00 for expenses for her school in Beaumont June 11, 12, and 13. Motion carried.

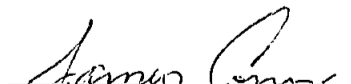

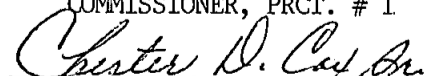
Mr. Sherlock was representing Tri-County to thank Commissioner Cox and Commissioner Conn for their help in distributing commodities this week.

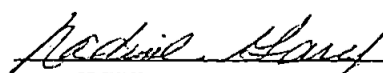
Motion was then made by Commissioner Cox, seconded by Commissioner Conn, that meeting recess. Motion carried.
