

Wednesday, May 31, the Honorable Commissioners Court met in a called session at 1:00 P. M., with the following members present:

Judge Smith called the meeting to order.

He then informed the court Judge Golden had asked for help in the District Clerk's office while Mrs. Walker is attending school next week. The Commissioners agreed to amend the budget to take care of this. This will be an agenda item Monday, June 5th.

Judge Smith also informed the court there will be some D.P.S. hearings in J. P. Court Friday, June 2, at 10:00 A. M. This will require the service of another J. P. instead of Judge Rash, who is in the hospital.

A discussion followed, concerning the \$40.00 Sheriff and Constable fees which are set by the commissioners court each year. The question is who gets the \$40.00 when a citation is served? Since the county pays on a salary basis, these fees should go into the county fund.

The County Group Health Insurance was again discussed. Judge Smith said he talked with Mr. Allison, with Texas Association of Counties, concerning the grace period with our insurance carrier. Mr. Allison advised him to send payment to Hillhouse Associates with a letter stating we are paying under protest. County Attorney Fortson advised the court to hold off payment until he is here June 5th.

Judge Smith also talked with Mr. Wolf with State Board of Insurance in Austin. Mr. Wolf promised to do some checking and call him back.

In the event the county receives confirmation there is no grace period under the current county employee group health insurance (New York Life), the court gives Judge Smith authority to approve payment immediately. This motion was made by Commissioner McDaniel, and seconded by Commissioner Conn. Motion carried.

Motion was also made by Commissioner McDaniel for employees to pay same premium for the month of June, and county will absorb remaining fee. Commissioner Conn seconded, and all voted for.

Motion was then made by Commissioner Cox, seconded by Commissioner McDaniel, to pay each elected official and county employee \$275.00 per month to obtain their own health insurance. Each elected official and county employee will be notified in writing their county health insurance will expire effective June 30, 1989. All voted for. Beginning July 1, all persons will be responsible for obtaining their own health insurance.


