

Monday, June 26, 1989, the Honorable commissioners' Court met in a regular session at 8:30 A. M., with the following members present:

Meeting was called to order by Judge Royce Smith, and prayer was led by Brother Clarence Howell.

The minutes for the June 12, 1989, Commissioners Court were read, and a motion was made by Commissioner Cox, seconded by Commissioner McDaniel, to approve the minutes. Motion carried.

The minutes for the June 19, 1989 Commissioners Court were read, with a motion by Commissioner McGee, seconded by Commissioner Conn to approve the minutes. Motion carried.

Motion was made by Commissioner Cox, seconded by Commissioner McDaniel, to approve bills listed. Motion carried.

Commissioner McDaniel made a motion to adopt the Resolution on Public Hearing on Private Sewage Facility Orders, seconded by Commissioner McGee. All voted for.

Three names were submitted for consideration in the appointment of J. P., Precinct # 1. The names were Robert E. Smith, Fred Clements, and Thomas Hamilton. Motion was made by Commissioner McDaniel, seconded by Commissioner Cox, to appoint Thomas Hamilton to complete the unexpired term of Frank Rash, deceased. Motion carried.

Commissioner McGee took over the meeting at this time due to Judge Royce Smith's having County Court.

After a lengthy discussion on the expense policy of County Constables, the court told the constables to check in with the sheriff's department before making a call and to keep a log of their mileage on the calls they make.


Constable Paul Clark ask the court what is going to happen in a year from now when the county's health insurance comes up for bid again, and would the court pay each individual to get their own insurance, instead of going through the County. The Court told Constable Clark that they could not guarantee getting a reasonable bid. If he does not want on the insurance, he does not have to get on it, but the county will not pay whatever it cost for him to get his own policy.


Residents from Sam Rayburn Estates wanted to know why the county did not maintain the road since there was a Grant of Easement for Public Road from W. L. Defoyd to Sabine County, signed on July 20, 1970. Commissioner McGee told the residents that he was told when this was done in 1970, it was done for the sole purpose of giving the residents a boat ramp. There was a verbal agreement in 1970 between the County of Sabine and the residents that the residents of Sam Rayburn Estates would maintain the road themselves. Commissioner McGee also told the residents that he would maintain their road, but not on a regular basis.




Commissioner McGee said the Pleasure Bend Road was settled.



Commissioner Carlin McDaniel introduced an Order and made a motion that the same be adopted. Commissioner Billy J. McGee seconded the motion for adoption of the Order. The motion, carrying with it the adoption of the Order, prevailed by the following vote:

AYES: 4

NAYES: 0.

The County Judge thereupon announced that the Order had been duly and lawfully adopted. The Order thus adopted follows:

ORDER ADOPTING RULES OF SABINE COUNTY, TEXAS
FOR
PRIVATE SEWAGE FACILITIES

WHEREAS, the Texas Department of Health and the Texas Board of Health have established construction standards for private sewage facilities to provide the citizens of this State with adequate public health protection and a minimum of environmental pollution; and

WHEREAS, the Legislature has enacted legislation, codified as Section 26.032 of Vernon's Texas Water Code Annotated, which authorizes the commissioners court of any county to enter an order, resolution, or other rule to abate or prevent pollution, or injury to public health arising out of the use of private sewage facilities; and

WHEREAS, pursuant to Sections 26.022 and 26.032, Vernon's Texas Water Code Annotated and Article 6252-17 of Vernon's Texas Revised Civil Statutes Annotated, due notice was given of a meeting and public hearing to determine whether the Commissioners Court of Sabine County, Texas, should enter an order, resolution, or rule controlling or prohibiting the installation or use of private sewage facilities in the unincorporated area of Sabine County, Texas; and

WHEREAS, said meeting and public hearing were held in accordance with the notice thereof, and the evidence and arguments there presented were considered by the Commissioners Court of Sabine County, Texas; and

WHEREAS, the Commissioners Court of Sabine County, Texas finds that the use of private sewage facilities in Sabine County, Texas, is causing or may cause pollution, and is injuring or may injure the public health; and

WHEREAS, the Commissioners Court of Sabine County, Texas, has considered the matter and deems it appropriate to adopt Rules regulating private sewage facilities to abate or prevent pollution, or injury to public health in Sabine County, Texas;

NOW, THEREFORE, BE IT ORDERED, ADJUDGED, DECREED, RESOLVED, FOUND AND DETERMINED BY THE COMMISSIONERS COURT OF SABINE COUNTY, TEXAS, SITTING AS THE GOVERNING BODY OF SABINE COUNTY, TEXAS, that:

(1) The matters and facts recited in the preamble hereof are hereby found and determined to be true and correct;

(2) The use of private sewage facilities in Sabine County, Texas, is causing or may cause pollution or is injuring or may injure the public health;

(3) The rule attached and appended hereto, entitled, "Rules of Sabine County, Texas for Private Sewage Facilities" are adopted and all officials and employees of Sabine County having duties under said Rules are authorized to perform such duties as required of them under said Rules.

(4) The County Commissioners Court of Sabine County, Texas, within five days after the entry of this Order, shall obtain a certified copy of this Order and said Rules and submit both to

the Texas Water Commission for their written approval thereof;

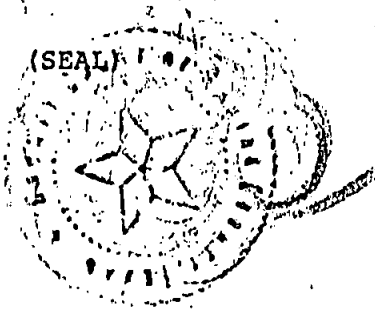
