Commissioner Billy McGee made a motion which was seconded by Commissioner Jimmy Conn, to approve payment of accounts and salaries. Motion carried.




Commissioner McGee then made a motion that meeting adjourn. Commissioner Conn seconded the motion, and motion carried.



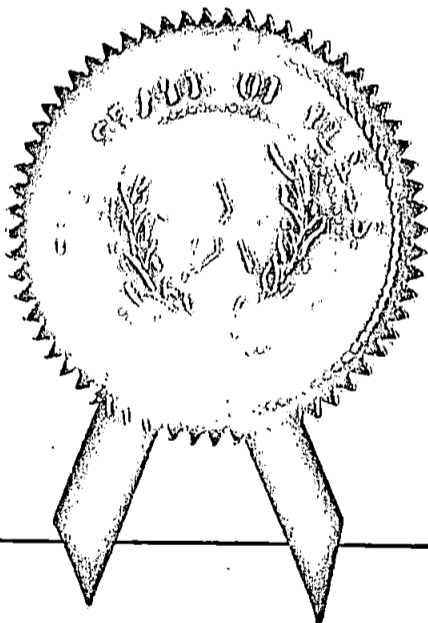
