Monday, December 11, 1989, the Honorable Commissioners' Court met in a regular session, at 8:30 A. M., with the following members present:

Meeting was called to order by Judge Royce Smith. Brother Clarence Howell led the opening prayer.

Minutes of the last meeting were read. After correcting the minutes to read that the gift certificates are to be used at Brookeshires, the minutes were approved. Motion was made by Commissioner Cox, seconded by Commissioner Conn. All voted for, and motion carried.

County bills were inspected for payment. After a discussion, the Commissioners decided to take out a bill for 2 flashlights. The Judge stated that the flashlights had not been received by his office. Motion was made by Commissioner Cox, seconded by Commissioner McDaniel, to approve payment of accounts and salaries. Motion carried.

Commissioner McDaniel made a motion, seconded by Commissioner McGee, to transfer \$14,779.26 from interest fund to salary fund. Motion carried.

Motion to approve written reports was made by Commissioner McGee, seconded by Commissioner Conn. Motion carried.

Mrs. Husband informed the Court that the State Comptroller wants the County to give the State the interest earned on the sales tax. It can either be paid now, or at the end of the year. If it is paid at the end of the year, a penalty will be added to it. There was no action taken.

Deputy Clerk Janice McDaniel, requested the Court to approve moving the voting place in Prct. 9 from the Community Center in Bronson, to the Fire Station, because of the condition of the building and there is no electricity. Commissioner Conn made a motion to approve, with Commissioner Cox seconding the motion. All voted for. Motion carried.

The clerk's office also requested that the court combine voting Prct. 5 with Prct. 10. The church building where Prct. 5 has been holding their election has been sold, and there is no place to hold it. Also the two voting precincts are about 4 miles apart. Commissioner Cox made a motion to approve; this was seconded by Commissioner McGee. All voted for, and motion carried.

These changes will have to be approved by the Justice Department in Washington D. C.

Judge Royce Smith explained to the Court the Resolution Supporting Fair and open Housing. Commissioner McGee made a motion to approve the Resolution, with Commissioner Cox seconding. Motion carried. See attached exhibit. the resolution supporting the

Commissioner McDaniel made a motion to approve/the Bill introduced by Representative Dan Morales. Commissioner McGee seconded. Motion carried.

Justice of the Peace Prct. 1, Thomas Hamilton, addressed the Court about the "Capias Pro Fine". He told the Court that he issues a "A Capias Pro Fine" when anyone has a fine, and they do not pay. He attaches a \$40.00 fee for issuing this. Senate Bill 356 covers this fee, effective September 1. \$35.00 and \$5.00 goes into Salary fund if the County issues the Capias. If the game warden or a department of public safety officer issues it, they get \$1.00 out of \$5.00 and \$7.00 out of the \$35.00.

The Courthouse will be closed December 22, 25th, and 26th for the Christmas Holidays. The next Commissioners Court will be on December 27th, 1989 at 9:00 A. M. Motion was made by Commissioner McGee, seconded by Commissioner Cox. Motion carried.

Commissioner Cox made a motion, seconded by Commissioner McGee, to waive Mr. Steven Craig Foster's not being on the agenda, and let him speak. Mr. Foster has property in Bronson. He does not live there, and he said he has not received his tax notice. He came into the tax office in 1979 and again in 1986. He assumed that he was current on his taxes and did not want to pay a penalty. Mrs. Husband, Tax Assessor/Collector, recomended to the Court that the penalty and interest on the years 79 thru 86 be dropped., but not from 1987 thru 1989. Commissioner Cox made a motion to accept Mrs. Husband's recomendation. Commissioner McGee seconded, and motion carried.

Commissioner Cox asked the court to waive the agenda to hear Mrs. Herndon from Shamrock Shores. The Property Owners' Association put up a 15 m.p.h. speed limit sign. They would like for the court to accept the speed limit and enforce it. It is to be put on the agenda for the next Commissioners Court meeting. The Court would like to check out the legality of it. Motion to post a notice of the speed limit on the bulletin board was made by Commissioner Cox, with Commissioner McDaniel seconding. Motion carried.

Commissioner Cox brought it to the attention of the people that Judge Royce C. Smith was elected to the Board of Judges and Commissioners Association. Judge Smith appointed Commissioner McDaniel as chairman on the Legislature Committée,

Commissioner McGee made a motion to adjourn. Commissioner McDaniel seconded, and motion carried.
