Meeting was called to order by Judge Royce Smith; Brother Clarence Howell led the opening prayer.

Minutes of the last meeting were read by Clerk, Nadine Gary. After the reading of these minutes, Commissioner McDaniel made the motion that they be approved after changing the wording as follows: to approve the resolution supporting the bill introduced by Representative Dan Morales. Commissioner McGee seconded the motion, and all voted for.

Monthly bills were inspected for payment. Commissioner McGee called attention to the bill from Fortenberry Insurance Agency in Newton. The County was charged a tax on the premium. After some discussion, this bill was pulled for further study. Commissioner McGee then made a motion, seconded by Commissioner Conn, to approve payment of accounts and salaries. Motion carried.

Ann Chaney, new editor of the Sabine County Reporter, was present for this meeting.

Commissioner Billy McGee made the motion to approve the resolution adopting rules ~~xxxx~~ of Sabine County for on-site Sewerage Facilities. Commissioner Carlin McDaniel seconded the motion, and motion carried.

Shamrock Shores Property Owners Association asked that speed limit signs be posted in their subdivision. At Commissioner Cox's request this will be an agenda item January 8th.







when the following business was transacted:

Commissioner Billy Joe McGee introduced Rules and motioned that the same be adopted. Commissioner Carlin McDaniel seconded the motion for adoption of the Order. The motion, carrying with it the adoption of the Order, prevailed by the following vote:

The County Judge thereupon announced that the Rule had been duly and lawfully adopted. The Order thus adopted follows:

ORDER ADOPTING RULES OF SABINE COUNTY
FOR
ON-SITE SEWERAGE FACILITIES

WHEREAS, the Texas Department of Health and the Texas Board of Health have established construction standards for on-site sewerage facilities to provide the citizens of this State with adequate public health protection and a minimum of environmental pollution; and

WHEREAS, the Legislature has enacted legislation, codified as Chapter 366, Health and Safety Code which authorizes any local governmental entity to petition the Texas Department of Health for authorization to promulgate rules to abate or prevent pollution, or injury to public health arising out of the use of on-site sewerage facilities; and

WHEREAS, pursuant to policies of the Texas Board of Health and Chapter 366, Health and Safety Code due notice was given of meeting and public hearing to determine whether the Commissioners Court of Sabine County, should enter an order, resolution, or rule controlling or prohibiting the installation or use of on-site sewerage facilities in the area of jurisdiction of Sabine County.

WHEREAS, said meeting and public hearing were held in accordance with the notice thereof, and the evidence and arguments there presented were considered by the Commissioners Court of Sabine County, Texas; and

WHEREAS, the Commissioners Court of Sabine County finds that the use of private sewage facilities in Sabine County, is causing or may cause pollution, and is injuring or may injure the public health; and

WHEREAS, the Commissioners Court of Sabine County, has considered the matter and deems it appropriate to adopt Rules regulating private sewage facilities to abate or prevent pollution, or injury to public health in the jurisdiction of Sabine County

NOW, THEREFORE BE IT ORDERED, ADJUDGED, DECREED, RESOLVED, FOUND AND DETERMINED BY THE COMMISSIONERS COURT OF SABINE COUNTY, SITTING AS THE GOVERNING BODY OF SABINE COUNTY, THAT:

- (1) The matters and facts recited in the preamble hereof are hereby found and determined to be true and correct;
- (2) The use of on-site sewerage facilities in Sabine County, is causing or may cause pollution or is injuring or may injure the public health;
- (3) The rules attached and appended hereto, entitled, "Rules of Sabine County, for on-site Sewerage Facilities" are adopted and under said Rules are authorized to perform such duties as required of them under said Rules.
- (4) The County Judge of Sabine County, Texas, within five days after the entry of this Order, shall obtain a certified copy of this Order and said Rules and submit both to the Texas Department of Health for their written approval thereof;
- (5) The County Clerk of Sabine County, Texas, is authorized to publish this Order and these Rules in the Reporter/Rambler, a newspaper of general circulation published in Sabine County, Texas, after the same are approved by the Texas Department of Health; and

(6) The Rules attached and appended hereto are incorporated herein as though fully set forth in writing in this Order.
