Due to the absence of Judge Smith, Commissioner McGee called the meeting to order. Brother Clarence Howell led the opening prayer.

Minutes of the last meeting were read by County Clerk, Nadine Gary. Commissioner McGee made the motion, which was seconded by Commissioner Cox, to approve minutes. Motion carried.

Judge Smith arrived and took over his duties as presiding Judge.

County bills were inspected for payment. Commissioner Chester Cox made the motion, which was seconded by Commissioner Jimmy Conn, to approve payment of accounts and salaries. Motion carried.

After the inspection of written reports presented, Commissioner McGee made the motion to approve reports. Commissioner Conn seconded and motion carried.

The security contract between Sabine county and the Corp. of Engineers was discussed. This contract provides for payment to the Sheriff Department for patroling at Mill Creek Park. Commissioner Cox made the motion which was seconded by commissioner McGee, to approve the contract. Motion carried.

Removal of books from the Law Library was discussed. Commissioner Jimmy Conn made the motion that Freddie Moody, the County Attorney's secretary, be responsible for checking law books out and in, so we can know where the books are. Commissioner Cox seconded the motion, and all voted for.

Don Dubose, a resident of Holiday Forest Subdivision in Prct. 2, met with the Court requesting the county to take over approximately .6 of a mile in this subdivision as county maintained roads. Commissioner McGee made a motion which was seconded by Commissioner Cox, to add this subdivision to the list of roads to be approved at a later date. Motion carried.

Commissioner Billy McGee made the motion to set speed limit on the Gooch Road at 15 miles per hour. Commissioner Cox seconded, and motion carried. This notice will be posted on the Bulletin Board in the Court House two weeks before this will be final.

Will Smith representing the Thomas Johnson Civic Club was present requesting a voting place at Thomas Johnson on Farm Road 1368, and informed the court he had contacted the Justice Department and they had told him to make his request to the Commissioners Court. Commissioner Carlin McDaniel made the motion, seconded by Commissioner Billy McGee, to approve the voting place at Thomas Johnson after Justice Deparment approval. All voted for. Mr. Smith informed the Court the old Thomas Johnson building can be made available as a voting place. After a 5 minute recess, court re-convened at 9:40.

Tom Philips, with the Sheriff Department, was present with a list of equipment and prices to be used on a Sheriff department car. This car was purchased from the Department of Parks and Wildlife. Sheriff Greer sold his car to Constable Jordan. No action was taken at this time. 6 10

We received two bids for a telephone system for the Sheriff department. One was from Contel and the other from Communications Interconnect Technology, operated by A. G. Mott of Sabine County. Sheriff Greer will decide which system to choose.

Sheriff greer presented specifications for a radio system for Sabine County. No action was taken at this time. Attached exhibit. Telephone and lights will be an agenda item March 26. Commissioner McGee made the motion, which was seconded by Commissioner Conn, to advertise for bids for radio communications for the Sheriff department. Motion carried. Bid opening will be March 26, at 9:00 A. M.

Commissioner McGee made the motion to contribute \$300.00 to a fund to help finance the trip to Washington in April. Commissioner Cox seconded, and motion carried.

The United States E. P. A. proposed regulations which would establish nationwide minimum standards for solid waste land fills. The Commissioners and Judges Association in 13 Deep East Texas counties will meet with E. P. A. and Senator Benson, Senator Gramm and U. S. Representative Charlie Wilson asking that regulations be adjusted to be more compatable with rural areas of Deep East Texas. Each county was asked to contribute \$300.00 for travel expense. Judge royce Smith and Commissioner Carlin McDaniel will be going from Sabine County.

This resolution was approved by the commissioners Court January 22, 1990.

Only two bids were received for patrol car for Sheriff Department. One was from Hemphill Motor Company, Hemphill for \$14,647.00. The other was from Greenville Ford-Mercury in Greenville, Texas for \$12,633.00. Commissioner Chester Cox made the motion, which was seconded by Commissioner Jimmy Conn, to accept the bid from Greenville Ford-Mercury. All voted for.

Several bids were received to buy used vehicles from the County. The following bids were accepted:
