Prct. # 2 Commissioner, Billy McGee said his dump is open Sunday, Monday, and Thursday 8:00 A. M., until 5:00 P. M.





Judge Smith informed the Court he is checking into having the locks on the outside doors of the court house repaired.


Motion was made by Commissioner Billy McGee and seconded by Commissioner Carlin McDaniel, to approve payment of bills. Motion carried.


