

Friday, June 29, 1990, the Honorable Commissioners' Court met in a called session at 8:30 A. M. with the following members present:

Meeting was called to order by Judge Royce Smith; Judge Smith also led the opening prayer.

Even tho the Sheriff Department was not on the agenda, Tom Philips was present to present a proposed Service Agreement to establish an agreement between Sabine County and other counties for the detention and care of prisoners. Sabine County can handle 8 or 10 prisoners from other counties, and this will mean additional money to be spent on the Sheriff Department. Jail Commissioner; Bob Dearing, said our present intercom system should be replaced, and also recommended a video system. This additional money will help pay for that.

Motion was made by Commissioner McGee and seconded by Commissioner Conn to waiver the Sheriff Department not being on the agenda. Motion carried. Commissioner McGee then made the motion to authorize Sheriff Greer to negotiate the contract. Commissioner McDaniel seconded, and motion carried.

David Burdette, the court house custodian, is no longer employed by the County. Since the Summer Youth program lasts until August 10, we will continue to use the Summer Youth until then, and will defer hiring a custodian. This will save the county approximately six weeks salary.

Salary review Committee was discussed. Commissioner McGee said when he left the last meeting, this review committee had been dropped from the agenda. Only one item was left, and that was group health insurance. Then this special meeting was called, and names submitted to form the committee. McGee then made the motion to rescind the motion to form the review committee. Commissioner Conn seconded, and motion carried, with three voting for, and Commissioner Cox voting against.

Commissioner McDaniel explained he voted to rescind the motion to form the review committee in order to give all four commissioners a vote. He then made the motion to form the committee, and received a second from Commissioner Cox... Commissioner Cox and McDaniel voted for, with Commissioner Conn and McGee voting against. Judge Smith broke the tie by voting against. He explained he voted against the issue until the court determined what guidelines committee is responsible for. This will be an agenda item July 9th.

Budget hearings are set for July 9th, 16, 23, and 30th, at 8:30 A. M.

Motion was made by Commissioner McGee that meeting adjourn.
Commissioner Conn seconded, and motion carried.
