Motion was made by Commissioner Billy McGee, and seconded by Commissioner Jimmy Conn, to accept the Interlocal Participation Agreement for Texas Association of counties Property and Casualty Self Insurance Fund. Motion carried. They will replace John Fortenberry Insurance Agency as physical damage carrier.


The budget was discussed but no action was taken.


Commissioner McGee had to leave at 10:00, so meeting adjourned.
