

Wednesday, August 15, 1990, the Honorable Commissioner's Court met in an emergency session at 8:30 A.M., with the following members present:

Meeting was called to order by Judge Royce Smith. Brother Tracy Lane led the opening prayer.

When the budget session started, Commissioner Cox said his feelings are that there should be no raises, but a tax increase to cover inflated budget. More budget discussion followed.

Motion was made by Commissioner Cox that salaries in all areas remain the same as 1989-1990, and adopt rest of budget as prepared. This motion died for lack of a second.

Diane Husband, Tax Collector, asked to go on record as not approving motion presented.

Mrs. Edith McCauley, with the County Review Committee, was present with comments to the Court.

Commissioner Conn made the motion to reduce the salaries of the four Commissioners, Sheriff and County Judge to \$17,500.00, and their expense account to \$4,800.00 per year. Also the Sheriff will have the same expense benefits as the ~~Judge and~~ Commissioners. Commissioner McDaniel seconded. Two voted for and Commissioner Cox voted against. Motion carried. Commissioner McGee was absent.

Commissioner Carlin McDaniel made the motion to amend employee vacation policy. Every employee gets one week vacation after one year employment. All employees with three or more years continuous service are granted two weeks, effective immediately. Commissioner Conn seconded, and motion carried.

Jim Burton, with the Sheriff department, was present requesting extra vacation time for holidays worked at the jail. Commissioner McDaniel made a motion which was seconded by Commissioner Cox, to table this until a later date. Motion carried.

Motion was made by Commissioner Conn to adopt the 1990-1991 budget. Motion failed for lack of a second.

After a 15 minute recess, Court reconvened at 11:55.


After more discussion, Commissioner Conn made the motion to approve the budget. Commissioner Cox seconded and motion carried with 2 voting

Commissioner McDaniel made a motion that meeting adjourn.


Commissioner Cox seconded. Motion carried.


COMMISSIONER, PRCT # 1




COMMISSIONER, PRCT. # 2

Draft #3 - Proposed Road Numbering and Address Standards
August 7, 1990

There are hereby established the following addressing standards for numbering property and numbering and/or naming public streets and roads within the unincorporated areas of Sabine County and any other areas by joint agreement of municipalities. Structures within this area are subject to addressing in accordance with this order.

NUMBERING ROADS:

Roads in the unincorporated areas will be numbered by 10's from the North end of the County in a West to East sequence.

Roads that continue through the County will have directional elements affixed for identification purposes - i.e. N.Hwy 87.

All names assigned to roads in conjunction with their number shall not be duplicated or have similar sounding names within the same telephone exchange or postal zip code. Roads that currently have duplicate names will require a name change to be decided by a lottery after first eliminating incorporated areas.

Street names and numbers will be continuous throughout the entire length of the street, even if it changes directions. New subdivisions will continue the name and number of an existing street on an adjoining plat.

All private roads with multiple family structures must be numbered (and named if desired) and specific addresses assigned to each family structure. If the private road has only a single family structure, and the entrance to the private road is from a numbered road, the private road will be treated as a driveway and an address assigned at the driveway. The street name will be that of the numbered road. Any numbered private road will have a sign provided by the County. If a private road with only one structure later has additional structures, the road will be numbered, addressed and put into the system.

Name changes are considered for historical or clarification purposes and are limited to reconsideration once a year during yearly update. Petition for change must be presented with signatures from 3/4 of property owners abutting street. This petition will be presented to the 911 Committee for recommendation to the County Commissioners.

ASSIGNING ADDRESSES:

The method of assigning addresses will be on the equal interval system (measuring of mileage distance along the road). The point of origin for each road will be based on its concentricity from the center of the City of Hemphill.

Numbers will be assigned on the interval of 5.28' or 1/1000 of a mile. Numbers will be assigned from the origin of the street with even numbers on the right and odd numbers on the left. All future road extensions will follow the same system.

The address will be assigned at the juncture of all driveways with the named road. Multi-unit structures will use individually addressed primary numbers whenever possible. Primary address numbers will not exceed five characters. Fractional addresses will not be allowed. Alpha numeric primary address numbers will not be used.

Non-specific addresses such as corner location addresses are not permitted.

The postal service list of abbreviations is the recommended standard to follow.

Final approval of street names and numbers resides with the Sabine County Commissioner's Court upon recommendation of the 911 Mapping and Addressing Committee.

Street numbering (and naming) and property numbering procedures are standards as authorized in the County Road and Bridge Act (Art. 6702-1, Texas Civil Statutes).

A plat book containing public roads with proper numbering assigned shall be kept on file for public use. Property undergoing subdivision or development in areas without street numbers or addresses must comply with the addressing procedures and be approved by the Commissioner's Court.

Notification in written form must be presented to the property owner and/or tenant when final assignment of addresses occurs. Notification also will be made to the U. S. Postal Service. Address will become effective upon notification.

New applications and maintenance of the County's addressing procedures will reside in the Commissioner's Court. Commissioner's Court shall determine the exact measurement for proper addressing and will furnish that address within one working day of request from utility companies. Commissioner's Court will also furnish that address to the appropriate postmaster. Utility companies will notify Commissioner's Court of any service initiation requests or changes.

Street signs shall be erected at all intersections of public roads and numbered private roads. For new property development, the signage will be required at the expense of the developer. Signs must conform to guidelines established by the County Commissioners.

PINEY WOODS RESOURCE RECOVERY CENTER

WHEREAS, the County of Jasper, hereinafter called "Jasper", the County of Tyler, hereinafter called "Tyler", the County of Newton, hereinafter called "Newton", the County of Sabine, hereinafter called "Sabine", and the County of San Augustine, hereinafter called "San Augustine" desire to enter into an agreement for the purpose of developing and operating an efficient solid waste management system for the entire five (5) county region;

WHEREAS, Article 4413 (32c), Vernon's Annotated Civil Statutes, provides authorization for local governments to enter into intergovernmental contracts, and Section 382.001, et seq. of the local government code provides authorization for county governments to jointly own and operate solid waste facilities;

NOW, THEREFORE, THIS AGREEMENT is hereby made and entered into by these five (5) counties and for the mutual consideration stated herein;

WITNESSETH

I.

Each county will be responsible for appointing representatives to a nine (9) member board with formal ratification by all incorporated cities with a population greater than one thousand people within that county. The number of appointments to the board for each county is as follows:

Jasper	3	Newton	2	San Augustine	1
Tyler	2	Sabine	1		

Board Members will serve alternating two (2) year terms. Lots will

be drawn for the first year to determine which members will only serve the first one year term.

II.

The board will petition all appropriate state and federal agencies for any available monies to cover all necessary startup costs possible. Each county will be liable for all shortages of money based upon their percentage of population in the region.

III.

Decisions by the Board will be made by a majority vote of members and counties voting.

IV.

The Board will establish all operating and management procedures for Piney Woods Resource Recovery Center (PWRRC). Board will also take all necessary actions in order to comply with all state and federal regulations concerning PWRRC.

V.

Each County agrees to accept liabilities or damages in the amount not to exceed the percentage of the population their particular county has of the region as a result of claims, demands, costs or judgments against PWRRC arising from any accident, injury or damage whatsoever, to any person or persons, or to the property of any person(s) or corporation(s) occurring during the performance of this agreement and on or about this project, except for any liability or damages caused by the negligence of the County, its agents, officer and/or employees. Sole liability will never rest on any county hosting a facility or facilities of PWRRC, unless caused by negligence of said County, its agents, officer and/or

employees.

VI.

Any County may leave association with the PWRRC by written notification to the Board and Other Counties no less than sixty (60) days prior, but said county will still be liable for its share of damages prior to that time.

VII.

Funding for PWRRC will come from fees and all other available monies from appropriate state and federal agencies. The Board will also have the authority to contract with other private or public entities to dispose of waste products in order to reduce the costs of operating for the region. * No entity within the five county region shall be assessed fees in an amount disparate from that assessed to any other entity within the region.






