

Monday October 8, 1990, the Honorable Commissioners Court met in regular session with the following members present:

Brother Clarence Howell led the opening prayer.

Commissioner Cox made a motion, seconded by Commissioner Conn to approve the minutes for the September 24th meeting. Motion carried.

Commissioner McGee made a motion to approve written reports. Commissioner McDaniel seconded. Motion carried.

Item # 3, Septic Tank Inspector renewal, was tabled until the October 23rd. meeting. Commissioner McDaniel made the motion, with Commissioner McGee seconding. Motion carried.

Due to November 12, 1990 being a County approved holiday, the first Commissioners Court in November will be held on November 13, 1990.

Ray Meleton, with Temple-Inland, ask the Court to declare the road known as the "Isom Road" as a public road. The property belongs to Mr. J. D. Conn. Mr. Conn has put up a gate and is not allowing any passage on his property. The road allowed access to property belonging to Temple-Inland and Mr. J. T. McSwain. The Court told Mr. Meleton that they would like to contact Mr. J. D. Conn in writing so that both parties interested could be available before a decision is made. This item is to be rescheduled for the November 13 Commissioner Court meeting. Commissioner McDaniel made the motion to reschedule with Commissioner Cox seconding. Motion carried.

Mr. W. H. (Bill) Goff and other veterans met with the Court to name the persons selected for the screening committee. Mr. Goff is chairman, with Arbie McGraw, Joe Hanna, Norman Birdwell and John Valentine serving. Alternate is Henry Lester. All these men are Veterans and are members of the V.F.W. or the American Legion or both. The deadline for accepting the applications is October 31, 1990 and they are to be turned in to the Commissioners Court. The Court would then turn the applications over to the screening committee which will in turn present the Court with approximately 3 names for the Court to choose an appointment from. Commissioner Cox made a motion to approve the committee and to publish an ad in the County Reporter for 3 weeks. Commissioner McGee seconded. Motion carried.

Mr. Perkins, with other residents of Sam Rayburn Estates, ask the Court if they would accept the roads inside their subdivision as County maintained roads, They are wanting to apply for a HUD grant, but the only way they can is if the county will accept their roads after they are brought up to State standards. If they are turned down on the grant, the county does not have to accept the roads. Mr. David Waxman, from Jasper, is willing to do the paper work for them and his salary would come out of the grant money. Commissioner McGee made the motion to put this item on the agenda for the October 22 meeting so that the residents can have Mr. Waxman present. Commissioner Conn seconded. Motion carried.

The Judge declared a ten minute recess.

When Court reconvened, Bill Barcheers with the 9-1-1 Committee, met with the Court to submit a "Proposed Resolution Road Numbering and Address

Standards." The committee wants the Court to accept the proposal and to authorize them to apply for grants to pay for the equipment needed to map out the County. If the county goes to a mapping company, it will cost about \$45,000.00. If the map has to be updated after a few years, that will be an additional fee. The committee would like to get a piece of equipment called "TRASTER II". This equipment could be attached to a car and is capable of mapping and numbering. It is used in connection with a computer. The cost for this equipment is \$65,000.00. Commissioner McGee made a motion, seconded by Commissioner Cox, to accept the resolution and to authorize the committee to apply for grants to help pay for the equipment. Motion carried. See attached exhibit.

Commissioner McGee made a motion to renew the time warrant and to pay the interest in the amount of \$4,793.56. This time warrant is for Prct. 2 1984 Mack dump truck, serial # 1M2B126COEA009698. The motion failed for a lack of a second. After a discussion, Commissioner McDaniel made a motion to renew the time warrant and pay the interest of \$4,793.56. Commissioner Conn seconded. Motion carried.

Commissioner McGee made a motion to make a time warrant for the amount of money needed, above the amount that is in the bank, to pay employees and accounts on a monthly basis until it pays for itself. Commissioner Cox seconded the motion. Motion carried with 3 voting for and Commissioner McDaniel voting against.

Commissioner McGee made a motion, seconded by Commissioner Conn, to pay accounts and salaries. Motion carried.

Item # 5 on the agenda is acceptance of county roads and mileage.

Prct. # 1- Harborlight, Strickland Road and Bob Putnam- 3.2 miles.




Commissioner McGee made a motion to accept roads for county maintenance. Commissioner Conn seconded. Motion carried.


