Monday, November 26, 1990, the Honorable Commissioners' Court met in a regular session at 8:30 A. M. with the following members present:

Judge Smith was not in his office, so Commissioner Billy McGee called the meeting to order. Brother Clarence Howell led the opening prayer.

Commissioner McGee asked that the minutes of the November 13 meeting be read first. After the reading of these minutes, he had the following corrections concerning the \$2,100.00 timber sale: The only bid received was a verbal bid from Charlie Waldrop. To make this payment Mr. Waldrop did work at the dump twice, and pushed the Dickey Cemetary Road.

After these corrections are made Commissioner McGee made the motion to approve the minutes. Commissioner McDaniel seconded, and motion carried.

Minutes for the November 9 meeting were read and approved. Commissioner Cox made the motion to approve and Commissioner Conn seconded. Motion carried.

Linda Tagliarini was present questioning the \$5.00 jury fee the County pays. The law states that we are to pay at least \$6.00. The Court agreed to ask County Attorney Dwight McDaniel to check to see if we will be in compliance if we start this increase in January.

Motion was made by Commissioner Billy McGee and seconded by Commissioner Jimmy Conn to change the December 24th meeting to Thursday, December 20, due to the Christmas Holidays. Motion carried.

Norman Shannon, representing the County review committee, informed the Court they are working on a Policies and Procedures Manual for the County.

Motion was made by Commissioner McGee and seconded by Commissioner Cox to waive the agenda to allow Ella Conner from Delta Heights Subdivision to address the court. Mrs. Conner stated for the record, she is not here for political reasons. She said the roads in the Subdivision are very bad, and are dangerous to travel. They have mail service for 45 families, and school bus service for 56 children. She asked that this road be given emergency attention before bad weather sets in. Commissioner McGee answered he will get to this road as soon as possible, but could not give a date.

Commissioner McGee brought up the issue about the timber sale on County property near Pineland. He stated the Court had accepted a verbal bid of \$2,100.00 from Charlie Waldrop. Mr. Waldrop was present and said he got in a financial bind and could not pay; instead he did work for the County in liew of a cash payment. Since there was no record of this, Commissioner McGee said Mr. Waldrop could write us a check for \$2,100.00, and we in turn could write him a check for the same amount. This work was done at the Prct. 2 dump and Dickey Cemetary Road.

All bills are sent to County Treasurer where they are listed for payment. After they are signed and approved, they are sent to the County Clerk's office where the checks are written.

Precinct 2 Commissioner Elect, Lynn Smith, asked if he will be presented with any more outstanding bills after he goes into office. Commissioner Billy McGee answered he has one more bill for over \$9,000.00, but it is an insurance deal, and he hopes to clear it up before January 1.

Commissioner McDaniel made the motion to request formal opinion from County Attorney concerning the paying of bills, also ask him to get a formal opinion from the Attorney General's Office concerning procedure for paying bills. Commissioner Cox seconded, and motion carried.

Motion was made by Commissioner McDaniel and seconded by Commissioner Conn, to pay accounts and salaries. Motion carried.

Court recessed for 10 minutes.

Tax Collector, Diane Husband asked that Delinquent Attorney Contract renewal be an agenda item at our next meeting, December 10.

Skate boarding on Court house property was discussed. Commissioner McGee made the motion which was seconded by Commissioner McDaniel to give County Attorney McDaniel authority to prepare a resolution to eliminate skate boarding around County property and to give Judge Smith the authority to sign resolution. Motion carried.

Motion was then made by Commissioner McGee that meeting adjourn. Commissioner Conn seconded, and motion carried.
