Lynn D. Hartzel, Sr., Ruth and Millard Raley, Ella Conner and Buddy Heiselbetz, residents of Delta Heights Subdivision, met with the court concerning their roads. The road had recently been graded, and the ditches were pulled. Since this they said the roads are even worse. Mr. Heiselbetz's wife drives the school bus, and reports the roads are dangerous for them. Mr. Hartzel stated his wife is an invalid, and can only ride lying down. He is afraid traveling this road will be injurious to her. Commissioner McGee answered the road is in better condition than when he took office 8 years ago.


Judge Smith explained to those present procedures for getting roads black topped.


Motion was made by Commissioner Cox and seconded by commissioner Conn, to pay accounts and salaries as presented. Motion carried.

The meeting was called to order at 6:35 P.M. by Chairman, Norman Shannon.

Mr. George Boyett let the group in opening prayer.

Mr. Shannon discussed with the committee the Unit Road System and he stated he felt the group had reviewed the system completely and at this time was ready for a recommendation concerning the system.

On a motion by Mr. Boyett and seconded by Mr. Reese the group voted to recommend to Commissioner's Court they adopt a Unit Road System. In addition this Committee recommends that if there is any private work being done on unaccepted roads or private property that it be immediately halted. Motion carried. In a letter addressed to Mr. Shannon, Mr. Payne voted for the Unit Road System. Mr. Payne was unable to attend this meeting.

The committee discussed the County not having a Personnel Policy and Procedure Manual, or job description for county employees. On a motion by Mr. Reese and seconded by Mr. Boyett the committee voted to recommend to Commissioner's Court they appoint a committee consisting of department heads in the county to prepare a Policy & Procedure Manual for all county employees and also job descriptions. Motion carried.

Mr. McDaniel, County Attorney suggested to the committee if they have any questions concerning legal matters of the county, they present the matter to the Commissioner's Court and then he would give his opinion to the Court and a copy of the opinion to the committee.

Mr. Shannon discussed with the committee the deficit the county has and will continue to have in the future. The committee felt the county will have to either increase revenue or decrease expenditures or both.

The next meeting will be held on January 8, 1991 at 6:30 P.M.

On a motion by Mr. Reese and seconded by Mr. Dion the meeting was adjourned.

CONTRACT FOR THE COLLECTION OF DELINQUENT TAXES

THE STATE OF TEXAS

COUNTY OF SABINE

THIS CONTRACT is made and entered into by and between SABINE COUNTY, acting herein by and through its governing body, hereinafter styled First Party, and the law firm of CALAME, LINEBARGER & GRAHAM, 1949 South I. H. 35, Austin, Texas, hereinafter styled Second Party.

I

First Party agrees to employ and does hereby employ Second Party to enforce by suit or otherwise the collection of all delinquent taxes, penalty and interest owing to First Party and all other taxing jurisdictions whose taxes are collected by First Party. Current taxes falling delinquent within the period of this contract shall become subject to its terms when placed in litigation or on the first day of July of the year in which the taxes become delinquent, whichever date is sooner.

II

Second Party is to call to the attention of the collector or other officials any errors, double assessments or other discrepancies coming under its observation during the progress of the work, and is to intervene on behalf of First Party in all suits for taxes hereafter filed by any taxing unit on property located within its corporate limits.

III

First Party agrees to pay to Second Party as compensation for the services required hereunder fifteen (15%) percent of the amount collected of all delinquent taxes, penalty and interest for the years covered by this contract, actually collected and paid to the collector of taxes during the term of this contract, as and when collected. All compensation above provided for shall become the property of Second Party at the time payment of the taxes, penalty and interest is made to the collector. The collector shall pay over said funds monthly by check.

IV

12/14/90 *R.S.*

This contract is drawn to cover a period of two years beginning January 1, 1990. Thereafter, this contract will continue on a month to month basis until such time as First Party notifies Second Party that it does not wish to continue the agreement. This agreement may be terminated by First Party by the giving of thirty (30) days written notice thereof to Second Party. Second Party shall have six months following termination of the contract to


reduce to judgment all suits filed prior thereto. In consideration of the terms and compensation herein stated, Second Party hereby accepts said employment and undertakes the performance of said contract as above written.

This contract is executed on behalf of First Party by the presiding officer of its governing body who is authorized to execute this instrument by order heretofore passed and duly recorded in its minutes.
