Motion was made by Commissioner Cox to transfer \$3,000.00 from R&B Tax to J. P. budget for part time secretary for J. P. 3. Commissioner Conn seconded, and motion carried, with four voting for, Commissioner McDaniel voting against.

Commissioner Cox made the motion to table Budget deficit until Monday. Commissioner Conn seconded, and motion carried.
