

Monday, January 28, 1991, the Sabine County Commissioners' Court met in a regular session at 8:30 A. M., with the following members present:

Judge Richard Smith was not present. He was attending a Conference in Lubbock for newly elected County Judges.

Meeting was called to order by Commissioner Chester Cox, acting judge pro-tem. Brother Clarence Howell led the opening prayer.

Arthur Ellison met with the Court expressing his appreciation for his appointment as Veterans Service Officer. At this time his office is open on Monday, Tuesday, and Wednesday.

MHMR Pledge of \$2,838.00 was tabled until our meeting Feb. 4.

Commissioner Cox recommended we re-appoint committee members in January each year.

Motion was made by Commissioner Conn and seconded by Commissioner Smith to re-appoint 9-1-1 Committee members for 1991. Motion carried. Names submitted are:

Commissioner Lynn Smith made the motion to appoint names just submitted. Commissioner Carlin McDaniel seconded, and motion carried.

Motion was made by Commissioner Carlin McDaniel to table appointment of Citizen Review Committee until February 4. Commissioner Conn seconded, and motion carried, with all voting for.

Norman Shannon, a member of the Committee, was present. Commissioner Cox suggested drafting a resolution expressing our appreciation for work done by the Review Committee, and send each of them a copy. Mr. Shannon had questions about the Unit Road System and Precedures Manuel they had recommended. Commissioner McDaniel explained nothing can be done about the Unit Road System without a petition from the voters asking for a special election. Work is being started for a precedures manuel.

Commissioner McDaniel made the motion to pay expenses for the four commissioners and County Judge to Seminar at College Station. Commissioner Smith seconded, and all voted for. Expenses for each Commissioner is \$275.00; Judge is \$300.00.


After a 15 minute break, Court re-convened.

Motion was made by Commissioner McDaniel and seconded by Commissioner Conn, to pay accounts and salaries. Motion carried.


A computer for the Judge's Office was discussed. This and budget discussion was tabled until February 4th.

Another agenda item for February 4 will be State Highway Funding Shortfall.


Commissioner Conn made the motion that meeting adjourn. commissioner Smith seconded, and motion carried.






COMMISSIONER, PRCT. # 1




COMMISSIONER, PRCT. # 2
