

Thursday, February 28, 1991, the Sabine County Commissioners' Court met in a special session at 10:00 A. M., with the following members present:

Meeting was called to order by Judge Richard Smith. Opening prayer was led by Commissioner Lynn Smith.

Attorney Barney Knight, with the Law firm of Bickerstaff, Heath and Smiley of Austin presented a re-districting proposal. A \$9,000.00 proposal would require some work locally with the County Clerk and County Attorney. This would consist of one public hearing. The attorneys' hourly rate is \$160.00 per hour. Attorney Lonnie Davis, Brother Will Smith, and Vollie Grace were present representing the Black in the county.

Motion was made by Commissioner Chester Cox to select the proposal of Hallman and Clunch of Nacogdoches. Commissioner Conn seconded, and motion carried.

A re-districting advisory committee will be formed. Motion was made by Commissioner McDaniel that anyone interested in serving on the committee submit his name to your commissioner or the County Judge by 4:00 P. M. March 8. The committee will consist of eleven members: 2 from each precinct, and 3 at large. Judge Richard Smith will serve as ex-officio member. Commissioner Conn seconded this motion, and motion carried.

Commissioner Chester Cox made the motion to appoint Judge Richard Smith to replace the late Judge Royce Smith as member of the Child Welfare board. Commissioner Jimmy Conn seconded, and motion carried.

Motion was made by Commissioner Carlin McDaniel to approve Resolution Authorizing the submission of a Grant request to the Governor's office, Criminal Justice Division, for the funding of the Deep East Texas Regional Narcotics Trafficking Task Force. Commissioner Cox seconded, and motion carried.

Commissioner Cox made the motion to approve Court minutes of February 8 as amended. Commissioner Conn seconded, and motion carried.


Vollie Grace will present the name of Black member to Commissioner McDaniel to serve on re-districting committee from Precinct 1. Attorney Lonnie Davis would like to serve from Precinct 4.

Commissioner Conn made the motion meeting adjourn. Commissioner Smith seconded, and motion carried.
