

Monday, March 25, 1991, the Sabine county Commissioners Court met in a regular session at 8:30 A. M., with the following members present:

Meeting was called to order by Judge Richard Smith. Brother Clarence Howell led the opening prayer.

Commissioner Conn made the motion to approve a 90 day vadility on county checks. Commissioner Cox seconded, and motion carried.

Motion was made by Commissioner Smith to reimburse Notary expense to Clarice Clark, J. P. # 5. Commissioner Cox seconded, and motion carried.

No action was taken for reimbursement of constable expenses.

Motion was made by Commissioner Jimmy conn and seconded by Commissioner Lynn Smith, to appoint Judge Richard Smith and Dean Crockett as board members to Tri-County Community Action. Motion carried.

Barbara Lee met with the Court requesting the acceptance of .6 mile of road in Brookeland Acreage in Prct. 2 as county maintained roads. Commissioner Lynn Smith recommended accepting this .6 mile of road. Commissioner Chester Cox seconded, but said we should ~~should~~ have a petition signed by the residents. Commissioner Smith then withdrew his motion until Mrs. Lee presents petition.

No action was taken for use of County equipment by City.

Rev. Ellis Kemper withdrew his name from the re-districting Committee. Motion was made by Commissioner Chester Cox to approve George Booth and Carl Garrett to this committee. Motion carried.

Motion was made by Commissioner Chester Cox, seconded by Commissioner Jimmy Conn, to approve payment of bills except those from East Texas Communications and Lone Star Pest Control. Commissioner Jimmy Conn seconded, and motion carried.

Odis Wooten from Houston county, and President of Judges and Commissioners Association presented a plaque to the family of Judge Royce Smith. This plaque was presented in ~~in~~ Judge Royce's honor.

Motion was made by Commissioner Lynn Smith and seconded by Commissioner Chester cox, to approve resolution presented to Temple-Inland which was table at our last meeting. Motion carried. This concernes locating a rock crusher on ~~the~~ ^{Temple} land in Sabine County.

Court recessed until 4:15 P. M.

At 4:15 P. M. court re-convened in District court room.


Judge Smith explained the County will be operating on borrowed money the next six months. This is legal, and can be paid over a long period of time.







Commissioner Chester Cox made the motion that meeting adjourn. Commissioner Jimmy Conn seconded, and motion carried.
