OF FAIR AND OPEN HOUSING AS SET FURTH IN TITLE VITI OF

THE CIVIL RIGHTS ACT OF 1968

WHEREAS, adequate housing is a necessary ingredient to the maintenance of the standard of living in this country; and

WHEREAS, it is important that every human being have access to adequate housing of his choice; and

WHEREAS, it is beneficial to the social and economic welfare of the entire country that every person have access to adequate housing; and

WHEREAS, the County Commissioner's Court recognizes the problems facing the citizens of SABINE COUNTY in obtaining access to adequate housing; and

WHEREAS, the law of the land is that no citizen can be denied access to housing of his choice because of race, color, religion, or national origin; now, therefore,

BE IT RESOLVED BY THE COUNTY COMMISSIONER'S OF SABINE COUNTY

THAT this County Commissioner's Court endorse and support the principle of fair and open housing; as set forth in Title VIII of the Civil Rights Act of 1968, and the right of every person to have access to adequate housing of his own choice without regard to race, color, religion, or national origin; and

THAT this County Commissioner's Court encourages all citizens to respect and support the law of the land in regard to the right of every person to have access to adequate housing of his own choice; and

THAT this County Commissioner's Court encourages all citizens to undertake voluntary actions to foster racial harmony, including individual and group decisions to promote fair and open housing individual commitment to avoid discrimination in all sale, all rental of property; and

THAT the County Commissioner's Court will cooperate with the LHA, LPA and nonprofit and limited dividend developers to provide low and moderate income housing within the County, and such development will have the full cooperation of the County Administration in determining locations and sites that meet HUD Criteria to the end that such housing will not be limited to any given area of the County and will be available to all citizens without regard to race, creed, color, religion or national origin. THAT the County will assist in promoting an affirmative action and advertising programs so that all housing will be made available to all citizens. Any board or group dealing with housing and appointed or licensed by the County will be directed to carry out the provisions of the Fair Housing Act of 1968.

THAT the County will inform the LHA, Realtors and other agencies, and to the greatest extent possible mortgage lenders and general public of the existence and implications of its adopted open housing resolution.

THAT the County develop policies that will help make a selection of land and/or sites available so that housing costs will remain at a reasonable level, particularly for low and moderate income families.

THAT the County will encourage local newspapers and owners of housing to comply with HUD Advertising Guidelines.

THAT the County will maintain cooperation with fair housing groups, human relations bodies and other social, civic and religious groups interested in facilitating open communities.

THAT the County will assist in the development of educational programs on equal housing opportunity, informing the real estate industry of their responsibilities under Federal law, encouraging minority citizens to exercise their rights under law, providing general human relations education and stating the Judge's commitment to fostering fair housing and defending the civil rights of all citizens.

THAT the County Commissioners Court designates the month of April as Fair Housing Awareness Month in SABINE COUNTY, TEXAS.

#### RESOLUTION

WHEREAS, the United States Environmental Protection Agency has proposed new regulations pursuant to Subtitle D of the Resource Conservation and Recovery Act (53 Fed. Reg. 33314, 8/30/88) which would establish nationwide minimum standards from municipal solid waste landfills; and

WHEREAS, those regulations, as initially published, were designed to eliminate small existing municipal landfills and encourage the creation of large regional state-of-the-art landfills; and

WHEREAS, due to comments from the State of Texas and the sparsely populated entities coalition (comprised of over 100 local governmental entities throughout rural West Texas) EPA is considering authorizating of variances from the Subtitle D regulations for areas of the state with low population density and low rainfall in which manicipal landfills or pose no significant threat of ground water contamination; and

WHEREAS, the State of Texas will likely be required to adopt its own regulations implementing any variance program authorized by EPA;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS COURT OF Sabine \_\_\_\_\_ COUNTY THAT:

- <u>Sabine</u> County is committed to the maximum flexibility possible for local governments under the anticipated EPA Subtitle D variance program, consistent with environmentally safe and prudent disposal of municipal wastes.
- 2. <u>Sabine</u> County urges the Texas Department of Health to make comments to the Environmental Protection Agency, formally or informally, to encourage the maximum flexibility of waste disposal for local governments under the EPA variance program consistent with environmentally safe and prudent disposal of municipal wastes;
- 3. <u>Sabine</u> County requests the Texas Department of Health in considering the adoption of state rules to implement the EPA Subtitle D variance program in a manner which affords local governmental entities the maximum flexibility consistent with environmentally safe and prudent disposal of municipal wastes.
- 4. <u>Sabine</u> County hereby requests its state legislative delegation, <u>consisting of Senator Haley</u> and Representative <u>Clemons</u>, to assist the County in obtaining comments and rules from the State Health Department which favor authorization of maximum flexibility for local governmental entities in the EPA Subtitle D variance program consistent with environmentally safe and prudent disposal of municipal wastes.
- 5. The Clerk is directed to transmit copies of this Resolution to the Texas Department of Health, State Senator Haley and State Representative <u>Clemons</u>.
