

Monday, April 22, 1991, the Sabine County Commissioners Court met in a regular session at 8:30 A. M., with the following members present:

Meeting was called to order by Judge Richard Smith. Opening prayer was led by Brother Clarence Howell.

Minutes of the last four meetings were read and approved. Motion was made by Commissioner Chester Cox to approve minutes for March 22. Commissioner Jimmy Conn seconded, and motion carried. Commissioner Cox also made the motion, which was seconded by Commissioner Conn, to approve minutes of March 25th and April 5th. Motion carried. Motion was made ^{by} Commissioner Lynn Smith, seconded by Commissioner Carlin McDaniel, to approve minutes for April 8th. Motion carried.

Motion was made by Commissioner Cox to approve monthly reports. Commissioner Smith seconded, and motion carried.

Resolution concerning State purchasing contract was tabled until our meeting May 13th.

Item # 5, air conditioner for transmitter room for Sheriff department was discussed. Someone from that department will check the size and price for an air conditioner and report at our next meeting.

Motion was made by Commissioner Cox and seconded by Commissioner Conn, to approve resolution supporting locating T.D.C. facilities in Jasper. All voted for.

Commissioner Lynn Smith presented a petition of 21 signatures out of a possible 29, requesting county maintenance of .6 miles in Brookeland Acreage Subdivision. Commissioner Smith made the motion to accept this as a county road. Commissioner Conn seconded, and motion carried.

Stephen Gray, from Arrowcrest Subdivision in Prct. 2, presented a petition requesting county acceptance of .9 mile in that subdivision. There are 17 property owners, and there were 12 signatures. Mr. Gray withdrew his petition based on the County Attorney's recommendation.

Precinct land fill fees was discussed. Bob Bourghs, with the Highway Department, Isaac Hawkins representing the Forest Service, and Tommy Neal, representing the city of Hemphill, were present, since they are also involved. Motion was made by Commissioner Cox, and seconded by Commissioner Conn, to table this until our next meeting. Motion carried. At this time Commissioner Smith and Commissioner McDaniel will present a proposal to be approved by the court.

Judge Smith informed the Court he had been in contact with Pete Tart, an attorney in Dallas concerning our budget deficit. Mr. Tart gave suggestions for solutions of our problem. Judge Smith will have a proposed resolution ready for our next meeting. This will concern Time Warrants for the Salary Fund.

No action was taken on bids for health insurance.



Commissioner Conn made motion meeting adjourn. Commissioner Cox seconded, and motion carried.






COMMISSIONER, PRCT. # 1




COMMISSIONER, PRCT. # 2

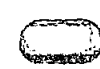

WHEREAS; Sabine County has determined that such a facility will have a positive impact on its surrounding area, and

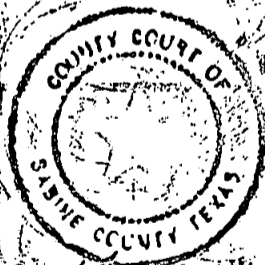
WHEREAS; this detention facility would greatly assist in the elimination of area-wide underemployment, and

A RESOLUTION ENDORSING AND SUPPORTING THE PRINCIPLE
OF FAIR AND OPEN HOUSING AS SET FORTH IN TITLE VIII OF
THE CIVIL RIGHTS ACT OF 1968

WHEREAS, adequate housing is a necessary ingredient to the maintenance of the standard of living in this country; and

WHEREAS, it is important that every human being have access to adequate housing of his choice; and

WHEREAS, it is beneficial to the social and economic welfare of the entire country that every person have access to adequate housing; and

WHEREAS, the County Commissioner's Court recognizes the problems facing the citizens of SABINE COUNTY in obtaining access to adequate housing; and

WHEREAS, the law of the land is that no citizen can be denied access to housing of his choice because of race, color, religion, or national origin; now, therefore,

BE IT RESOLVED BY THE COUNTY COMMISSIONER'S OF SABINE COUNTY

THAT this County Commissioner's Court endorse and support the principle of fair and open housing; as set forth in Title VIII of the Civil Rights Act of 1968, and the right of every person to have access to adequate housing of his own choice without regard to race, color, religion, or national origin; and

THAT this County Commissioner's Court encourages all citizens to respect and support the law of the land in regard to the right of every person to have access to adequate housing of his own choice; and

THAT this County Commissioner's Court encourages all citizens to undertake voluntary actions to foster racial harmony, including individual and group decisions to promote fair and open housing individual commitment to avoid discrimination in all sale, all rental of property; and

THAT the County Commissioner's Court will cooperate with the LHA, LPA and nonprofit and limited dividend developers to provide low and moderate income housing within the County, and such development will have the full cooperation of the County Administration in determining locations and sites that meet HUD Criteria to the end that such housing will not be limited to any given area of the County and will be available to all citizens without regard to race, creed, color, religion or national origin.
