Ms. Anderson addressed the Court on the possibility of the County or another entity contracting the operations of the Nutrition sites in the County. Ms. Anderson answered questions from the Court and concerned citizens. Ms. Anderson informed the Court that the first step would be for Judge Smith to submit a Letter of Intent to DETCOG.






There being no further business Commissioner Cox made a motion to adjourn with a second from Commissioner Smith. Motion carried.


RESOLUTION

WHEREAS, Sabine County Commissioners' Court, meeting in a called session June 27, 1991, notice of said meeting having been legally posted and said meeting being open to the public, passed a motion authorizing the issuance of a time warrant for the purpose of paying in whole or in part, the County's obligations for paying salaries and wages of County employees together with the acquisition and purchase of necessary supplies and services to the County; and



BE IT THEREFORE RESOLVED that the Sabine County Commissioners' Court orders the Treasurer of The County of Sabine, Texas to deliver a Time Warrant in the amount of \$50,000.00, to First State Bank, Hemphill, Texas.

BE IT FURTHER RESOLVED that the County will provide for the payment of said Time Warrant from the levy and collection of ad valorem taxes in the county as provided by law.
