Commissioner Cox made motion which was seconded by Commissioner Conn, to certify 1991 Appraisal roll. Motion carried.



Tax Collector, Diane Husband, stated 92% of 1991 taxes have been collected.




Commissioner Cox made the motion, seconded by Commissioner Conn that meeting adjourn. Motion carried.

RESOLUTION

A RESOLUTION OF THE COUNTY COMMISSIONERS COURT OF THE COUNTY OF SABINE, TEXAS, AUTHORIZING THE SUBMISSION OF A TEXAS COMMUNITY DEVELOPMENT PROGRAM APPLICATION TO THE TEXAS DEPARTMENT OF COMMERCE FOR THE HOUSING DEVELOPMENT FUND; AND AUTHORIZING THE COUNTY JUDGE TO ACT AS THE COUNTY'S CHIEF EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE IN ALL MATTERS PERTAINING TO THE COUNTY'S PARTICIPATION IN THE COMMUNITY DEVELOPMENT PROGRAM.

WHEREAS, the County Commissioners Court of the County of Sabine desires to develop a viable urban community, including decent housing and a suitable living environment and expanding economic opportunities, principally for persons of low/moderate income; and


WHEREAS, certain conditions exist which represent a threat to the public health and safety; and

WHEREAS, it is necessary and in the best interest of the County of Sabine to apply for funding under the 1991 Texas Community Development Program;


NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COMMISSIONERS COURT OF THE COUNTY OF SABINE, TEXAS:

1. That a Texas Community Development Program application for the Housing Development Fund is hereby authorized to be filed on behalf of the County with the Texas Department of Commerce.
2. That the County's application be placed in competition for funding under the Housing Development Fund.
3. That the application be for \$ 250,000.00 of grant funds to carry out the Housing Rehabilitation and Modification Program for the Elderly and Disabled.
4. That the County Commissioners Court directs and designates the County Judge as the County's Chief Executive Officer and Authorized Representative to act in all matters in connection with the application and the County's participation in the Texas Community Development Program.
5. That it further be stated that the County of Sabine is committing \$-0- from its Local Funds as a cash contribution toward the construction activities of this Housing Rehabilitation/Modification Project and \$-0- in-kind services.
