- 3. That the application be for \$250,000.00 of grant funds to carry out the Housing Rehabilitation and Modification Program for the Elderly and Disabled.
- 4. That the County Commissioners Court directs and designates the County Judge as the County's Chief Executive Officer and Authorized Representative to act in all matters in connection with the application and the County's participation in the Texas Community Development Program.
- 5. That it further be stated that the County of Sabine is committing \$-0from its Local Funds as a cash contribution toward the construction activities of this Housing Rehabilitation/Modification Project and \$-0kind services.
