

Monday, September 9, 1991, the Sabine County Commissioners' Court met in a regular session at 8:30 A. M., with the following members present:

Judge Richard Smith called meeting to order.

Minutes of the last 5 meetings were read by County Clerk, Nadine Gary. Approval of August 12th meeting was tabled until the minutes of the night meeting are added and approved. Motion was made by Commissioner Chester Cox, and seconded by Commissioner Jimmy Conn, to approve minutes for August 19. Motion carried. Commissioner Cox then made the motion, seconded by Commissioner Smith, to approve minutes for August 23, after the addition of Jack Puckett's name being^{as} present in sheriff Greer's behalf. Motion carried. Commissioner McDaniel made the motion to approve minutes for August 26th. Commissioner Smith seconded, and motion carried. Motion was made by Commissioner Smith to approve minutes for August 30. Commissioner Conn seconded, and motion carried.

3 - County Barn was tabled.

Motion was made by Commissioner Lynn Smith to accept roads in Toledo Village as County maintained roads. Commissioner Chester Cox seconded, and motion carried.

Two bids were received for oil mixer. George Banes presented three proposals. One for \$70,000.00, one for \$49,000.00, and one for \$37,800.00. The other bid was from Conley, Lott, Nichols Machinery for \$65,000.00. Motion was made by Commissioner Cox, and seconded by Commissioner McDaniel, to table action on these bids. Motion carried.

5 - J. P. Thomas Hamilton asked to transfer funds in order to pay his secretary thru September. Commissioner Carlin McDaniel made the motion to approve payment. Commissioner Lynn Smith seconded, and motion carried. The money will be transferred at the end of September.

Bill Barcheers was present to give a 9-1-1 report. He informed the Court that after talking with postal officials in Tyler, they were told we have to use road names instead of numbers.

Mr. Renny Reed was present to explain the bids for mixer from George Banes.

8 - State Purchasing contract was discussed. Judge Smith stated there is a yearly fee of \$125.00. Motion was made by Commissioner McDaniel to pass a resolution to participate in State contract. Commissioner Conn seconded, and motion carried.

Commissioner Chester Cox made the motion to place a voting box at Thomas Johnson and move precinct 15 voting place from Pine Park Church to Strickland Crossing Church of God, and leave the other voting places as is. Motion carried, with Judge Smith

and Commissioners Cox and Conn voting for; Commissioners Smith and McDaniel voted against.

Commissioner McDaniel made the motion to have only 2 Justice and Constable precincts; One for Commissioner Precinct 1 and 4, and one for commissioner precinct 2 and 3. Commissioner Smith seconded, and motion carried. These will go into effect when terms of offices are up.

11 - Personnel Policy Manuel was tabled until next meeting.

12 - Although W. C. Vickers was on the agenda, he was not present.

13 - Storm water run off permit questioner forms were given to each Commissioner. This will be an agenda item Sept. 16.

Motion was made by Commissioner McDaniel to pay \$10,000.00 plus interest of \$3,250.51 on time warrant for precinct 1, and renew for one year. Commissioner Smith seconded, and all voted for. This leaves a balance of \$19,026.12 still due.

Time warrant, re-districting, and discuss gravel situation with Temple-Inland Representative will be agenda items Sept. 23.

Motion was made by Commissioner Smith to approve line item transfer of \$500.00 for District clerk from schools to deputy and assistants. Commissioner Conn seconded, and motion carried.

14 - Pay accounts and salaries: Motion was made by commissioner McDaniel to pay bills except the one from Eastex communications for \$643.50. Commissioner Conn seconded, and motion carried.

Agenda for Monday, September 16 - re-districting, personnel policy manuel and storm water run-off permit.

Meeting adjourned.

CERTIFICATE OF RESOLUTIONS

I, Nadine Gary, do hereby certify that I am the duly elected, or appointed and acting ~~Secretary~~/Clerk of County of Sabine, a political subdivision duly organized and existing under the laws of the State of Texas (the "Lessee"); and that the following resolutions have been presented to and duly adopted by the Commissioners Court at a meeting duly held and convened in accordance with applicable law on the 22nd day of July, 1991.

WHEREAS, the Lessee is entering a Municipal Lease and Option Agreement (the "Lease") dated Aug 12, 1991 with Capital City Leasing, Inc.; and

WHEREAS, Lessee has carefully reviewed its financing requirements for the current calendar year and reasonably expects that it will not issue more than ten million dollars (\$10,000,000) of tax-exempt obligations during the calendar year;

NOW, THEREFORE, BE IT RESOLVED, that the Lessee be, and is hereby authorized to enter into the Lease with Capital City Leasing, Inc. for a period of 60 months, and be it further

RESOLVED, that an official of the Lessee be, and is hereby authorized, empowered and directed to sign on its behalf the Lease and any schedules, notes, UCC financing statements or other instruments issued under the provision of the Lease and any other instrument or document which may be necessary in connection with fulfillment of the provisions of the Lease.

RESOLVED, that pursuant to Section 265(b)(3) of the Internal Revenue Code of 1986, as amended, this Lease be and is hereby designated a "qualified tax-exempt obligation" includable within the ten million dollars (\$10,000,000) of the aggregate issues designated as "qualified tax-exempt obligations" for the calendar year within which this Lease is entered into.

RESOLVED, that Lessee shall not designate more than ten million dollars (\$10,000,000) of tax-exempt obligations during the current calendar year as qualified tax-exempt obligations and Lessee, does not reasonably expect to issue more than ten million dollars (\$10,000,000) of tax-exempt obligations during the current calendar year.
