

Monday, September 16, 1991, the Sabine County Commissioners' Court met in a called session at 8:30 A. M., with the following members present:

Judge Smith led the opening prayer.

2 - Re-districting - Motion was made by commissioner Chester Cox to rescind his motion of September 9th which read "to place a voting box at Thomas Johnson and move precinct 15 voting place from Pine Park Church to Strickland Crossing Church of God, and leave all other voting places as are." Commissioner McDaniel seconded, and motion carried.

Motion was then made by commissioner Cox and seconded by Commissioner Conn, to re-draw voting precincts and consolidate Sexton and Isla with Geneva, and Rosevine and Pine Park with Bronson. Then add a box at Thomas Johnson; this will leave a total of 8 boxes. Motion carried.

Motion was made by Commissioner Cox to adopt resolution showing which boundary county roads will be maintained by each commissioner. Commissioner McDaniel seconded, and motion carried. "See attached list."

The Court gave Judge Smith the authority to write a statement showing the reason they chose re-districting plan C over Plan A.

Storm water run-off permits will be kept on file, but do not have to be approved and sent in.

Motion was made by Commissioner Lynn Smith to set the Sheriff and constable fees at \$40.00; the same as in previous year. Commissioner Chester Cox seconded, and motion carried.

5 - Elevator maintenance - Tabled until next meeting. Judge Smith will get more information on charges.

6 - Courthouse custodian - Judge Smith will run an ad in the paper for this.

The Court gave county Clerk, Nadine Gary, the authority to complete the Lateral Road report.

Personnel Policy Manuel was reviewed Commissioner McDaniel made the motion to approve policy of Applicability. Commissioner Smith seconded, and motion carried. Motion was made by Commissioner Smith to adopt Implementation and Administration. Commissioner Cox seconded, and motion carried.

Commissioner Smith made the motion, seconded by Commissioner Conn to rescind motions on pages 2 and 3. Motion carried.


Commissioners Court shall review personnel policy manuel, and amend these policies as necessary; then adopt entire manuel at once.


Commissioner Chester Cox made the motion to pay accounts. Commissioner Jimmy Conn seconded, and motion carried.
