Meeting was called to order by Judge Richard Smith; Brother Clarence Howell led the opening prayer.

Motion was made by commissioner Lynn Smith and seconded by Commissioner Jimmy Conn, to approve minutes for September 9. Motion carried. Commissioner Conn made the motion to approve minutes for September 16. Commissioner cox seconded, and motion carried.

Darwin Foster, a representative from Temple-Inland, was present to discuss gravel situation for County roads. Commissioner McDaniel said the county is running out of iron ore gravel, and asked for help from Temple. Commissioner smith said the oil companies want to go to permit hauling; Temple and Mr. foster are against that. Mr. Foster said they will work with us on roads they use. No action was taken.

Mr. and Mrs. Roy Hunt met with the court concerning recent vandalism at their home. Mr. Hunt said the person responsible has been caught.

Commissioner McDaniel made the motion, seconded by Commissioner Cox to re-appoint Diane Husband and T. A. Lane as members to Sabine County Appraisal District Board of Directors. Motion carried.

Judge Smith reported he had two estimates for elevator maintenance. River City Elevator in Nacogdoches has gone out of business. Tom Harrison who worked for them a long time, is now working out of Tyler. This company is known as Esco. W. A. Dyson now works for him. Judge Smith called them Saturday to check the elevator. This will cost approximately \$500.00; we have a bill for June for \$146.40, which we have not paid. Esco's cost to upgrade elevator for a maintenance contract will be \$1,640.00. This does not include parts and no monthly maintenance quote given. Tolar Inspectors out of Fort Worth gave a price of \$1,683.00 plus \$190.00 for photo eyes safety device. Full service contract for \$150.00 per month, which includes one inspection per month. We will have to pay travel one way if called in early. Motion was made by Commissioner McDaniel to go with Tolar to upgrade elevator so we can get a maintenance contract with them. Commissioner Cox seconded, and motion carried.

Robert Hamilton was not present, but was on the agenda asking that the road to his farm off FM 3121 be accepted as a county maintained road. The Court agreed to accept this as a county road if Mr. Hamilton will sign a 40 foot easement with the county.

Court went into executive session.

Re-convened into regular session at 11:10 A. M.

Judge Smith informed the court there is still \$32,000.00 in. the budget, so it is not necessary to make another time warrant. Commissioner Chester Cox made the motion to pay accounts and salaries. Commissioner Conn seconded, and motion carried. Meeting adjourned.

INTERLOCAL AGREEMENT FOR STREET REPAIR, AND MAINTENANCE BETWEEN SABINE COUNTY AND THE INCORPORATED CITY OF BRONSON, TEXAS 811

THE CITY OF TEXAS () COUNTY OF SABINE )

THIS AGREEMENT, made and entered into by and between SABINE, TEXAS, hereinafter called "County", acting herein by and through its County Judge and County Commissioners, pursuant to a resolution duly passed by the Commissioners' Court of said County, and the duly incorporated municipality of Bronson, Texas, hereinafter called Bronson, a body corporate and politic, organized and existing under the General Laws of the State of Texas, acting herein by and through its Board, thereunto duly authorized;

### WITNESSETH:

WHEREAS, said County and Bronson, pursuant to the provisions of the Interlocal Cooperation Act, (Article 4413 32c), Revised Civil Statutes of Texas, 1925, as amended have determined that it would be to the best interest of such County and Bronson and to the inhabitants thereof that provisions be made that Sabine County will maintain and repair roads passing by and through the incorporated city limits of Bronson, Sabine County, Texas.

NOW, THEREFORE, THE BRONSON AND SABINE COUNTY AGREE that County may perform work for Bronson consisting of the repair, and maintenance of roads, or other like facilities contained in Bronson, provided however, all such work shall be performed in accordance with the following terms and conditions:

1. Bronson, acting by and through its governing body, herein request Sabine County to perform any project within the scope of

this Agreement. The request shall be in writing and directed to the Commissioner's Court. The request shall be made on the prescribed form attached hereto as Exhibit A. Prior to action on the request, the Commissioners Court may require Bronson to provide any information it shall deem necessary to evaluate such request, including plans and specifications for the proposed project.

2. Before Sabine County may begin work on the project the Commissioners' court shall give specific written approval to such project in a document separate from this Agreement, which written consent shall describe the type of project to be undertaken and the location thereof. Such consent shall be made on the prescribed form attached hereto as Exhibit B. At Sabine County's sole discretion, such consent may be conditioned Upon Bronson's prior approval of the project cost. Should such consent be so conditioned, Sabine County shall furnish Bronson a written estimate of the cost of performing such work. No action shall be taken until such estimate is approved by Bronson.

3. Bronson, in consideration of the full and true performance of such work by Sabine County hereby agrees and binds itself to pay the Sabine County all costs actually incurred by Sabine County in performance of the work, including but not limited to the costs of all labor, material, and equipment used by Sabine County.

4. Upon completion, Sabine County shall provide Bronson a statement of  $\frac{20000}{5000}$  for this work performed. Bronson shall remit to Sabine County payment of such costs within thirty (30) days of receipt of the aforementioned statement.

5. Bronson hereby represents that funds are available from the

budget for the current fiscal year for payment for work anticipated to be performed hereunder.

6. This Agreement shall be effective on and from its date of execution for a term of one (1) year after the date hereof. This Agreement may be terminated at any time by either party upon 30 days written notice given by certified mail, receipt requested.

7. The work done by Sabine County pursuant to this Agreement shall be executed, performed and completed in good, substantial and workmanlike manner to the satisfaction of Bronson.

8. Bronson shall specify in writing any complaint as to the quality of workmanship performed by Sabine County.

9. Nothing herein is intended to require Sabine County to provide any right of way. It is understood and agreed that the providing of rights of way, engineering work, and plans, designs, and specifications shall be at the expense of Bronson.

10. Sabine County shall have the right and authority, upon reasonable notice to the proper Bronson official, to block streets and roadways, park equipment on rights of way, and to do all things reasonably necessary to perform such construction, maintenance or repairs.

11. Sabine County shall not be liable for any delay which may be caused by reason or account of unavoidable accident or other circumstances beyond its control. It is further understood and agreed that Sabine County shall perform such work only after and subject to fulfilling commitments and priorities on other Sabine County projects. Sabine County, upon completion of such work, shall clear away all tools, machinery, debris, and any materials or things which may be lying about the worksite, and shall do everything necessary to finish all the work in a complete and workmanlike manner, both in appearance and in fact.

12. Sabine County shall be liable for accidents and damages which may occur during such time and which may arise from the performance of any work by Sabine County under this Agreement (only to the extent provided by law.) Sabine County, during the progress of such work, shall adequately protect the work, adjacent property, and the public.

13. Bronson hereby agrees to indemnify and hold Sabine County harmless for all damages, liabilities for which may be imposed by law upon Bronson for acts of omission or commission by Bronson

during the term and performance of this contract. EXECUTED this the 14th day of October 197/.
