#9 - Personnel - County Clerk, Nadine Gary, presented a letter requesting chief deputy pay for Tina Crofford, one of her deputies. This was refused at this time.

City asked for easement from County to cut tree and put utility pole on County property for new post office. Easement to City of Hemphill will be an agenda item at our next meeting.

Ingred Morris will also be on the agenda.

Court recessed until 10:30.

Consider sale of county equipment: agenda item next meeting.

\$7,800.00 in grant money for video equipment for jail and cars for deputies has been approved by Temple.

Motion was made by Commissioner Chester Cox, and seconded by Commissioner Jimmy Conn to approve payment of bills, except one from Esco. Motion carried.

Commissioner Cox made the motion to approve as a matter of record, certification of continuing education for County Treasurer, Ollie Faye Sparks. Commissioner Conn seconded, and motion carried.

More of the personnel policy manual was reviewed. This will again be an agenda item at our next meeting.

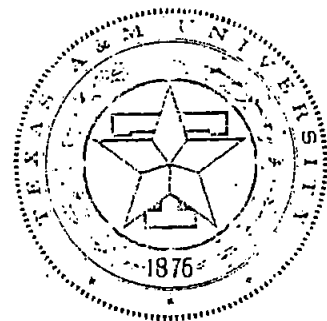
