### § 263.006. Exchange of Real Property

(a) The commissioners court of a county, by an order entered in its minutes, may authorize the exchange of an interest in real property owned by the county for an interest in real property owned by an individual, private partnership or corporation, or other private entity, to be used for one or more public purposes for which a county otherwise may acquire land. The exchange transaction may include a partial cash payment.

(b) Except as provided by Subsection (d), before the commissioners court exchanges an interest in real property under this section, notice that the county will consider offers for an exchange of the interest in real property must be published in English in a newspaper of general circulation in the county in which the real property is located and in the county that owns the interest if not the same county. The notice must be published once a week for three consecutive weeks before the date of the exchange, with the date of the first publication being before the 20th day before the date of the exchange.

(c) The county shall obtain an appraisal of the fair market value of the interest in real property owned and being exchanged by the county, and the appraisal is conclusive for purposes of this section of the value so determined. An exchange may not be made under this section for a total consideration, including cash and interest in real property, that is less than the fair market value of the interest in real property being exchanged by the county. The commissioners court may reject any and all offers made under this section.

(d) An exchange of an interest in real property originally acquired by the county for street, right-of-way, or easement purposes as consideration for the acquisition of another interest in real property for street, right-of-way, or easement purposes is not subject to the notice requirements of Subsection (b) but is subject to the appraisal required by Subsection (c), whether or not the exchange transaction includes a partial cash payment.

(e) This section does not apply to the exchange of an interest in real property owned by a county for an interest in real property owned by the United States, this state, or a municipality or other political subdivision of this state.

Dear Judge Smith:

We received your letter regarding our request for payment for redistricting services rendered. We will be unable to attend your meeting on November 25, 1991; and therefore submit this letter for your consideration.

We regret our submitted bill exceeded the estimate. However, we did indicate to the court in our original letter that we billed by the hours actually worked. More hours were required for the project than anticipated because of numerous requests made by various county officials and were beyond our reasonable expectations. Not only did we do as requested, we also did the work in a timely fashion. A listing of work not anticipated at the beginning of the project includes the following:

- analysis of Plan B as submitted by the Justice of the Peace to determine the constitutionality and workability
- b) verification of the boundaries of Plan C and preparation of a suitable map of the plan with recognizable boundaries and not just a vague computer map which would not be satisfactory for submission purposes or public display
- c) computation of voter registration rates by race for each voting box, commissioner precinct, JP precinct, constable precinct past and present; the county clerk usually provides this information, could not do so, and is a requirement for the submission package to the Department of Justice
- d) a revision of our plan prior to open submission to the court--done at the request of Judge Smith and Commissioner Smith
- e) three meetings in Nacogdoches (actually a savings to the county since we did not have to travel to Hemphill)
- f) advisory committee appointed after our proposal was accepted; caused additional meetings with the committee

We have been involved in redistricting projects with cities, counties, and school districts for 16 years and have never presented such a detailed bill as we have already provided for you. In 16 years no political entity has questioned, challenged, or delayed payment for our services. We did not request any advance for our services as did some competitors and our final bill still is quite less than the original bids of our competitors.

We notified Judge Smith when we were approaching the original bid figure, and obviously had uncompleted requests and work to do. We were told to proceed and told the information was being shared with the court.

We understand your concern and cautiousness with the county's resources, but we have done the work in good faith, done what was requested, and did not do any extra work unless it was requested. By tabling the decision to pay us and delaying the payment is unprofessional. You should handle this matter in a timely fashion as you expected us to perform in a timely fashion.

We expect prompt payment for our services rendered on behalf of Sabine County.


