

Thursday, December 19, 1991, the Sabine County Commissioners' Court met in a regular session at 8:30 A. M., with the following members present:

Judge Richard Smith called meeting to order. Brother Clarence Howell led opening prayer.

Minutes of the last meeting were approved as read.

Motion was made by commissioner Chester Cox to appoint Ingred Morris and Jack Leath to the Highway Task Force. Commissioner Jimmy Conn seconded, and motion carried.

#3 - Commissioner Lynn Smith supported the motion to adopt the resolution of participation in Performance Reward Program. Commissioner Jimmy Conn seconded, and motion carried. This would be a grant of \$50,000.00, and would benefit the citizens of Sabine County, and could provide financial support for the Community corrections and criminal justice needs in our county.

#4 - Precinct Land fills will be an agenda item January 13th.

Jack Tagliarini was present, and asked that the agenda be waived concerning support of building of Hemphill library. Commissioner Jimmy Conn made the motion to waive the agenda. Commissioner Chester Cox seconded and motion carried. Mr. Tagliarini asked for a resolution to support the building of the library, (not financially, but for building one here.) Land and building if paid for. It is known as J. R. Huffman Public Library. The board has requested \$140,000.00 from Temple. Mr. Tagliarini and other board members will meet with Buddy Zigler and Arthur Temple, office managers for T.T.L. Temple Foundation tomorrow, December 20th. They will study request. Motion was made by Commissioner Cox and seconded by Commissioner McDaniel, to support resolution. Motion carried, with all voting for. Judge Smith will type resolution, stating it was passed by unanimous vote; County Clerk can attest it, and Court will not have to sign resolution.

Judge Smith reported that of the 37 proposals presented at the Regional Review Committee meeting we scored number 37. This concerned residents repair of elderly and handicapped citizens of Sabine County. Commissioner Lynn Smith said Judge Smith did an excellent job presenting the proposal, so it was no fault of his.

An agenda item for January 13 will be discuss Piney Woods Solid waste management.

Commissioner Conn made the motion to pay bills. Commissioner Smith seconded, and motion carried.

Motion was made by Commissioner Cox that meeting adjourn.

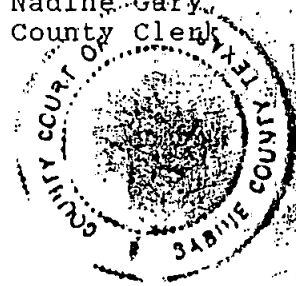

WHEREAS, a Public Library provides access to quality literature for all persons; and


WHEREAS, only one Public Library currently exists to serve all the people of Sabine County; and


WHEREAS, it is important and beneficial to all persons living in Sabine County to have ready access to the wonderful resources available at a Public Library; and
