

Monday, January 27, 1992, the Sabine County Commissioners' Court met in a regular session at 8:30 A. M., with the following members present:

Meeting called to order by Judge Richard Smith. Brother Tracy Lane led opening prayer.

Minutes of the last meeting were read and approved.

#2 - Discuss gravel pit property: Heirs want to sell. Jim Nethery will be contacted about location of property. No action was taken at this time.

#3 - Appoint Salary Grievance Committee members: Names drawn from last year's grand jury were: Kenneth Webb, Robert Wagstaff, and Ray Crocker. Clerk will notify them in writing.

A group of residents from McMahan Chapel Road in Precinct 3, were present concerning an 8 foot culvert that replaced a bridge that was broken on this road. Mr. and Mrs. Wendell Eddings were the speakers for the group. They explained this culvert is higher than the road, and causes flooding so they cannot get in and out after a rain. They also said the creek opening is 30 feet, and culvert is 8 feet.

Mr. HERNSBURGER, Highway Department Engineer, explained he thinks back water is causing the trouble; if not, the road would wash out. Water backs up below road almost as much as it does above it. Water doesn't show to move fast, so it does not wash out road.

Mrs. Eddings stated that at one time last year they were trapped behind flood water over 30 hours.

Jimmy Conn, Commissioner in this precinct, stated he replaced the bridge that was broken with the culvert because he could not afford a bridge that would handle the heavy traffic on this road.

Bruce Ferguson said road does wash a little, but is in better shape now than ever before.

Mr. Wilson said he has lived on his place 14 years, and has never seen creek over road until it gets over his property. Creek goes down by side of his property, cuts across - runs into Polo Gaucho just before it gets to his property. When creek fills up, it backs up into his pasture and upon the road. He does not think the culvert has anything to do with it.

Mrs. Eddings does not believe it is a back-up problem. She said water runs swiftly until it hits culvert, turns to South until it gets to the lowest part of road and within a few feet of culvert, goes right back into creek. Mr. and Mrs. Eddings maintains the creek is 30 feet wide at culvert.

Commissioner Conn stated bridge on Polo Gaucho cost \$7,500.00; he has already spent \$1,500.00 on a culvert. Commissioner Cox stated when state granted disaster funds for bridges washed out a

couple of years ago, they allowed approximately \$300.00 for repair on this bridge.

Commissioner Conn thanked Jimmy Welch for crushed rock and for the hauling he had done for the County.

Steve Hollis, an attorney with the Law Firm of W. Z. Weems, informed the court if the Eddings can't get satisfaction in this, they will have to pursue remedies under law.

Dwight McDaniel, our County Attorney, stated there may be two problems involved; the culvert may be too small, and gets stopped up. He thinks Mr. Conn has given this a lot of thought. If he builds the road up any more, the water will back up to Bolt's house.

Commissioner Cox stated that with HERNSBURGER'S help, maybe a solution can be found. Maybe we can resolve it somehow. No action was taken.

After a 15 minute recess, Commissioner McDaniel stated they are having a meeting in Austin concerning the Highway office in Lufkin. He thinks it is critical to keep Lufkin office open; not combine it with Beaumont. Commissioner McDaniel will check into this.

#5 - Commissioner McDaniel informed Court a group of citizens have volunteered to help clean up and re-roof the county barn. He then made the motion to roof the building with County and volunteer labor - County will furnish material. They will advertise for bids for material. Commissioner Conn seconded; motion carried, with 3 voting for and Commissioner Smith voted against. Bid opening will be February 24th.

#6 - Commissioner Cox made the motion to accept bid of \$62,750.00 for used excavating and grading machine submitted by Hi-Way Equipment of Houston. Commissioner Smith seconded. This will not be put in debt service, but we will pay 20% down. Motion carried, with 3 voting for; Commissioner Conn voted against.

#7 - Creation of Public Agency for Solid Waste Landfills: No action taken. There will be a meeting concerning this in Woodville January 30, 1992.

#9 - Pre-approval of bills: Motion was made by commissioner McDaniel to continue to pay II Sisters for meals for the jail the same as is the rest of the calendar year. Commissioner Conn seconded, and motion carried.

#11 - Purchase of Property: This is a repeat of # 2.

#12 - County Pond Pen: Motion was made by commissioner Cox to authorize Commissioner McDaniel to purchase material and go ahead with building the pond pen on County Property in Hemphill. Commissioner Conn seconded, and motion carried.

#13 - Pay accounts and Salaries: J. P., Prct. 2, Jimmy Clark, presented a bill for re-imbusement to pay substitute teacher while he attended school. This bill, along with doctor bills for LeRoy Rash, were pulled at this time. Motion was made by Commissioner McDaniel to pay remaining bills. Commissioner Cox seconded, and motion carried.
