
# 1 - Amend budget- Commissioner McDaniel made the motion to leave as is, and not amend the budget. Commissioner Conn seconded, and motion carried.


Court recessed until 10:00 A. M.




Commissioner McDaniel has tubing for pond pen, and will see to getting work done.

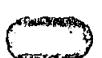


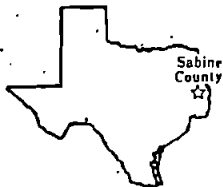

Re: Question - Is the county liable for payment of the medical expenses incurred by an inmate of the county jail if the costs are not directly related to his incarceration. Is the inmate considered indigent, and what are the guidelines for determining this?

ATTN:

ANSWER - (Art. 104.002 of Texas C.Cr. Proc.) (d) A person who is or was a prisoner in a county jail and received medical, or health related services shall be required to pay for such services when they are rendered. If the inmate cannot pay for such services because he is indigent (as defined in Chapter 61, Health and Safety Code) the county shall assist the prisoner in applying for reimbursement through that chapter or the hospital district of which the party is a resident. An inmate who does not meet the eligibility for assistance payments shall remain obligated to reimburse the county for any medical, dental or health services provided and that county shall have the authority to recover the amount expended in a civil action.

INDIGENT - (As defined in Chapter 61 of Texas Health and Safety Code) The critical word here is "indigent." In chapter 61 of the Health and Safety Code there is no set definition for the word indigent. Rather there are tests which the Department of



Human Services administers.

Whether the individual is entitled to money from the state should be determined by TDHS. The inmate or former inmate should get in touch with the TDHS, and set up an appointment with income assistance. If he qualifies the money would come from the state.

Although the county may be held liable for an indigent's care, the county is the payor of last resort and shall provide assistance only if other adequate public or private sources of payment are not available.

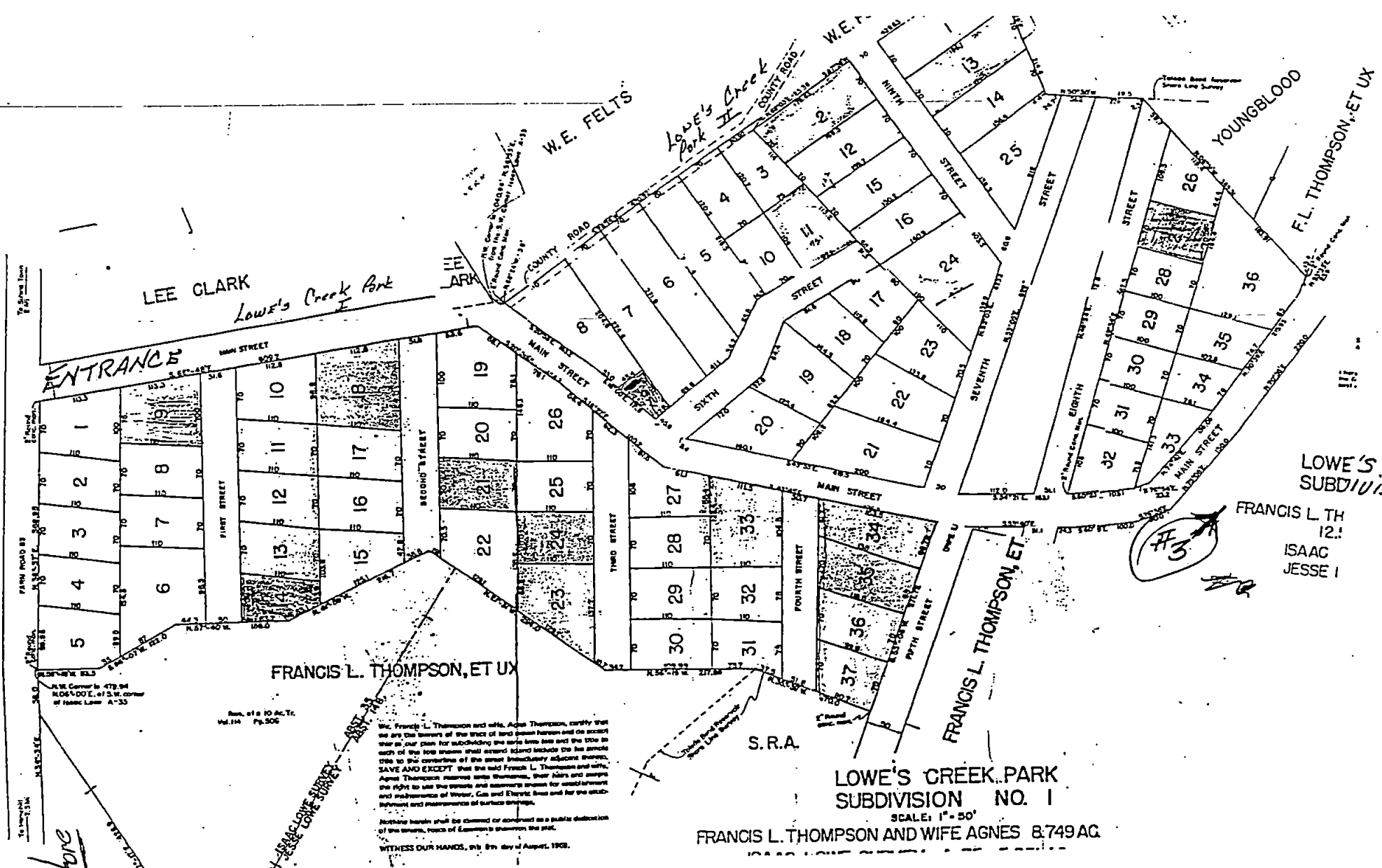

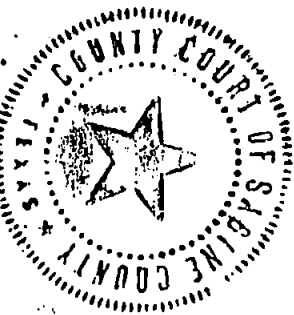
