Court met at 10:00 A. M. for second meeting.






Motion was made by Commissioner Chester Cox to advertize for bids for county Audit for 1991 and 1992. Commissioner Conn seconded, and motion carried.



AND, WHEREAS, THE BLUE STAR MEMORIAL HIGHWAY OF TEXAS IS SPONSORED BY THE HEMPHILL GARDEN CLUB IN COOPERATION WITH THE STATE HIGHWAY AND PUBLIC TRANSPORTATION COMMISSION:
