

Monday, July 20, 1992, the Sabine County Commissioners Court met in a called session at 8:30 A. M., with the following members present:

Judge Richard Smith called meeting to order. Brother Tracy Lane led opening prayer.

Bill Vrooman, agent for Lamar Life, explained the county was refused for Health insurance because of five heart surgeries since 1985.

Raymond Parr presented a proposal for Security Life: \$500.00 deductible; \$10,000.00 Life Insurance - \$163.60 per employee per month. \$250.00 deductible; \$10,000.00 Life Insurance - \$181.60 per employee per month. These rates are good for 12 months after bid is accepted. Also, with this proposal prescription drugs are paid 100% after deductible is met.


Motion was made by Commissioner McDaniel to authorize Mr. Parr to obtain applications from County employees in order to get a firm bid from Security Life, but continue to pay Guardian Life until it is approved. Commissioner Chester Cox seconded, and motion carried.


Commissioner Lynn Smith made the motion to approve a line item transfer of \$600.00 from Court Appointed Attorney to District Clerk deputy for part time help. Commissioner Jimmy Conn seconded, and motion carried. Judge Smith recommended this transfer from Court Appointed Attorney due to the murder trial earlier in the year.


