Commissioner Chester Cox seconded, and motion carried. This will make a total of \$159,225,00 in debt service. commissioner Cox made the motion to adopt debt service as presented. Commissioner McDaniel seconded, and motion carried.

Court recessed until 10:00 A. M.


Meeting was called back to order.


Motion was made by Commissioner McDaniel to split the Bureau of Land Management check equally 4 ways. Commissioner Conn seconded, and motion carried.


