

Monday, August 17, 1992, the Sabine County Commissioners' Court met in a called session at 8:30 A. M., with the following members present:

Meeting called to order by Judge Richard Smith; Commissioner Lynn Smith led opening prayer.

#3 - Roads in Precinct 4 - Commissioner Cox asked the Court to accept roads that go through U.S. forest Service land and on to private property to save them yearly permits. If county accepts roads it does not mean they will have to maintain them, but people can get in and out without paying permit. Motion was made by Commissioner Chester Cox to accept these roads. Commissioner Lynn Smith seconded, and motion carried.

Jack Powell representing Sabine Investment, presented a plat of Laguna Shores, Section #10. Motion was made by Commissioner Smith, seconded by Commissioner Cox, to accept plat and roads in subdivision. Motion carried. Sabine Investment will take care of erosion problems if it affects roads.

Judge Smith asked Court to waive agenda to discuss Farm Road program, and off system bridges. He explained the more people served per mile, the better chance for Farm to Market Road.

El Camino is already locked in. Forest Service sets priority. It is now number 3 on list. Commissioner McDaniel asked court to take a record vote and ask people in Precinct 1 to contact their State Representative and U. S. Forest Service to push to move this road back up in priority.

Precinct 2 Roads:

Spur off 3315 to Laguna Shores and Pleasure Bend; also extension 2928 to Fox's Lodge, Lakeview Campground and Timberlane. Pat Fox was present concerning the extension to 2928. James H. Hanley presented a petition with 132 names for the Pleasure Bend Road. Also there were letters from Postmaster Timothy Krantz and Superintendent Douglas Butler concerning the Pleasure Bend Road.

Precinct 3 - Commissioner Jimmy Conn presented the County Line Road in Sam Rayburn Estates with an extension to 2866 to two parks. Mr. Perkins and Gentry Seale represented those residents. This is approximately 6.5 miles and goes into two counties.

Precinct 4 - Commissioner Chester Cox presented a road to connect Hwy. 87 and 276 in north end of county. A bridge was built on this road about 2 years ago at a cost of \$120,000.00; this should be a plus in getting a road through. Will probably serve as many ^{as} 10 subdivisions, and is approximately 2.9 miles.

Judge Richard Smith presented a proposed budget which will be available for inspection in the County Clerk's office.

Court recessed and re-convened at 10:30.

Judge smith then told the Court we can submit more than one road for Farm to Market program, and Department of Transportation will evaluate them. Commissioner Jimmy Conn made the motion to submit the four roads discusse today. Commissioner Chester Cox seconded and motion carried.

Diane Husband, Tax Collector, explained 92% rate of collection can be applied to debt service only.

Motion was made by Commissioner Lynn Smith to set proposed tax rate at .33¢ per \$100.00. Commissioner Carlin McDaniel seconded, and motion carried.

Public hearings will be set for August 27 and September 8 at 6:00 P. M. August 27 agenda - Proposed tax rate; and Proposed Budget. September 8 agenda - Public Hearing on Proposed Budget- Public Hearing on Proposed Tax Rate. Adopy Budget, Adopt Tax Rate.

Budget Session continued at 1:30 P. M.

Agenda for August 24 - Discuss J. P. Salaries.

Off System Bridges : D.O.T. indicated they have money to build bridges as long as county pays 20% of price. At first Court was not interested. Commissioner Smith reported Walter indicated we may get grants for the 20%. If so, the following bridges will be considered:

Select Audit Firm:




This was tabled until Monday, August 24.


Motion was made by Commissioner Cox to pay bill to B & B Auto for alternator retair. Commissioner Conn seconded, and motion carried.


