

On Wednesday, February 24, 1993, the Sabine County Commissioner's Court met in an emergency called meeting with the following members present:

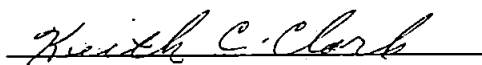

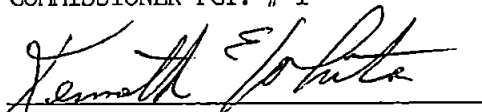
No further action was taken by the Court.

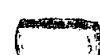
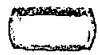
