Meeting called to order by Judge Larry Hyden.




Agenda item March 22 - "Resolution to approve Texas Antiquities Code." Also resolution for Teen Court.


Motion made by Judge Hyden that "Due to exhaustion of the County pit and our inability to locate another source and considering the welfare and public safety of citizens on County Roads and the fact this situation could not have been foreseen when the budget was prepared and approved and further that limited funds for purchase of gravel was budgeted, and further that sufficient funds, \$200,000. is currently in the R&B Reserve account, and further that a source of supply has been determined at a cost to the County at \$0.75/yard from H. G. Byley, the budget be amended in an amount sufficient to cover the purchase of said gravel and such purchases shall be so identified by the treasurer and an amount equal to, and not exceeding to be transferred from the "Reserve" account to cover such purchases. Commissioner Kenneth White seconded, and motion carried.


