Monday, March 22, 1993, the Sabine County Commissioners' Court met in a regular session at 8:30 A.M., with the following members present:

Judge Larry Hyden called meeting to order, with Brother Clarence Howell leading opening prayer.

Minutes of the last two meetings were approved as read. County Extension Agent, John Toner, presented his report for approval.

7- Rex Mixer - Court agreed to submit a bid of \$5,000.00
to Police Jury in Louisiana for Rex Mixer.

8 - Motion made by Commissioner Lynn Smith to accept Resolution of Sabine county Commissioners' Court opposing authority granted the Texas Antiquities Committee. Commissioner Keith Clark seconded, and all voted for.

11 - Commissioner Clark made motion which was seconded by Commissioner Cox to approve Resolution authorizing the submission of grant request to the Governor's Criminal Justice Division for funding to the County of Sabine, Texas for a program known as "Sabine County Teen Court." Motion carried.

12 - Motion made by Commissioner Keith Clark to support resolution for U.S. Highway 190 as a major East-West Corridor providing access to East Texas, and Highway 96 as a major North-South Corridor providing access to East Texas. Commissioner Smith seconded, and motion carried.

Commissioner Kenneth White made motion to set a speed-limit of 15 miles per hour on Dick Letney Road. Commissioner Keith Clark seconded, and motion carried.

Agenda items next meeting will be "Speed limit Beechwood 2; also Speed limit Byley Road in Precinct 1."

2- Three bids were received for Tractor and Bush hog: Jasper Equipment company, Fish and Steel Equipment, and Leon Bennett Equipment. Bid from Leon Bennett was not labled as such. It was opened by Judge Hyden's secretary, and re-sealed when she saw it was a bid. No one saw the amount of bid. Motion by Commissioner White, seconded by Commissioner Cox, to accept bid. Court was advised they can accept bid for tractor from one company, and bush hog from another, if desired.

Motion made by Commissioner White to accept bid of \$17,995.00 for Ford tractor from Jasper Equipment Company and bid of \$1,295.00 for bush hog from Fish and Steel Company. Commissioner Clark seconded, and all voted for.

3 - Three bids received for Sheriff patrol car: Al Meyer Ford, Inc.; Lufkin; Hemphill Motor Company, and Tipton Ford, Inc. Nacogdoches. Motion made by Commissioner Clark, seconded by Commissioner Kenneth White to accept bid from Tipton Ford for

\$12,202.00. All voted for. This patrol car will be paid for from current funds.

5 - Bids for Office supplies: There were 2 bids submitted for office supplies: Rogers Office Supply and Christian Country Book Store. Motion made by Judge Hyden, seconded by Commissioner Clark, to accept bid from Christian Country Book Store. Motion carried.

Three bids were received for printing: Rogers Office Supply, Christian Country Book Store, and Angler's Printing and Publishing. Motion made by Judge Hyden to accept bid of Christian Country Book Store for printing. Commissioner Clark seconded, and all voted for. (Only two bids were presented; Rogers Office Supply did not bid

4 - Only one bid received for fuel: that from Terrill Petroleum Co. Motion made by Commissioner Clark to accept this bid. Commissioner Smith seconded, and motion carried.

Seventeen insurance proposals were received, but no action was taken at this time.

Sheriff W. G. Bradberry ask the court to approve a resolution by the Sabine County Sheriff's Department authorizing the submission of a grant request to the Governor's Office Criminal Justice Division for the funding of the Deep East Texas Regional Narcotics Trafficking Task Force. \$5,000.00 is budgeted for this year, which will take care of the first payment of \$3,475.00. Motion made by Commissioner Chester Cox to approve resolution for Task Force for 1 year, and give Judge Hyden authority to sign for Court. Commissioner Kenneth White seconded, and motion carried.

Motion made by Commissioner Smith to pay accounts and salaries. Commissioner Clark seconded, and motion carried.

Court recessed until 1:00 P.M. Will re-convene in District Court room.

When Court re-convened at 1:00 P.M., Mr. Hilderbrand and Mr. Marietta were present representing Kirby Lumber Company. Witnesses for this side were Rob Smith, former commissioner, Thomas Hamilton, and Palmer Conner. Glenn McDaniel was present in his behalf. His witnesses were Carlin McDaniel and Clement McDaniel. This meeting was to determine if the Frank Tatom Road in Springhill is a public or County Road. After discussion, Court went into Executive Session at 2:30 P.M.

Returned to regular session at 3:10 P.M.

The road is not a county road. The road is a public road; it was aquired through prescription. It is owned by Kirby and held in trust by Sabine County. Sabine county will discontinue all maintenance, but continue to hold the road in trust and so reaffirm it is a "Public Road."
