Monday, April 12, 1993, the Sabine County Commissioners Court met in a regular session at 8:30 A. M., with the following members present:

Judge Hyden called meeting to order; Brother Clarence Howell led opening prayer.

Minutes of the last two meetings were approved after correction of March 22. There were only two bids submitted for printing supplies. Rogers Office Supply did not submit a bid.

Commissioner Lynn Smith made motion to approve written reports. Motion seconded by Commissioner Keith Clark, and motion carried.

Charles Craig, a resident of Delta Heights, had questions concerning roads in that subdivision. He feels they should be in better condition. Judge Hyden asked that he give the Court 60 to 90 days to get these roads repaired. Mr. Craig agreed.

Mr. and Mrs. Albert Werner, residents of Sam Rayburn Estates, met with the Court concerning a road off County Line Road- They stated this road is used for nothing but a dumping ground for trash. No action was taken, but Commissioner White will check with the Corp of Engineers since this road belongs to them.

#4 - Motion was made by Commissioner Chester Cox to pay invoice of \$11,995.95 to Piney Woods Solid Waste Agency. Commissioner Lynn Smith seconded, and motion carried.

#5 - The invoice from Neches Communications, Inc. is up from \$350.00 to \$500.00. Commissioner Cox made the motion to pay the \$500.00. Commissioner clark seconded, and all voted for. This higher priced frequency is more competitable with the Sheriff Dept.

#6 - Sheriff Bradberry explained he had a letter from Tipton Ford stating Ford Motor company is offering advantagous savings on orders for police packages placed through April. He asked to purchase two new vehicles for replacement in his department. With this deal we can save approximately \$12,000.00 on two vehicles. Motion made by Commissioner White, seconded by Commissioner Clark, to go out for bids. The County retains the right to accept or reject bids. All voted for. Bids will be accepted until April 23.

#8 - Personnel & Police Manuel was discussed. Commissioner Lynn Smith questioned the sick leave section. It was discussed reducing sick leave time to 40 hours per year, with no carry over. No action taken.

Motion made by Commissioner Smith to advertise for bids to sell used County equipment. This was seconded by Commissioner Clark, and motion carried. Equipment to be advertised is: 5 yard dump bed, 1975 Dodge dump for salvage, Sheriff Department car, and Rex mixer, and tractor. Also Commissioner Prct. 4 will trade 160 gallion maintainer for road base material.

Motion made by Commissioner Keith Clark to set speed limit

in Beechwood II at 10 miles per hour, "Children Playing." Commissioner Chester cox seconded, and motion carried. Commissioner Smith made motion to approve action already taken by Commissioner Clark on Byley Road in Precinct 1. Speed limit set is 30 miles per hour. Commissioner Gox seconded, and motion carried.

Motion made by Commissioner Smith to authorize County Judge to search for and attain an architect for assistance in renovation of the Court House. Commissioner White seconded, and motion carried. Cost for architect will be from \$3,000.00 to \$5,000.00.

#13 - Budget Amendments - No action taken.

#14 - No line item transfers.

Commissioner Kenneth White made motion to proceed with lease contract for gravel with Ronnie and Vicci Fuller. Commissioner Keith Clark seconded, and motion carried, with all voting for.

#12 - Review lease agreement with Commercial Equipment -Motion was made by Judge Larry Hyden to table Bo-mag lease agreement until a later date. Commissioner Lynn Smith seconded, and . motion carried.

Motion made by Judge Hyden to renew Time Warrant on gradall by paying what is due on April 28th. Commissioner Smith seconded, and motion carried. Commissioner Lynn Smith made motion to renew for one year. Commissioner Chester Cox seconded, and motion carried.

Motion made by Commissioner Cox to pay accounts and salaries. Commissioner White seconded, and motion carried.

Although this was not on the agenda, the Court agreed on a division of Road and Bridge funds for 1993-1994. This can come under General Business. Commissioner Smith made the motion to divide funds as follows: Prct. # 1 - 23%; Prct. # 2 - 25% Prct. # 3 - 25% Prct. # 4 - 27%

Commissioner White seconded. It was a tie vote, with Commissioner Smith and White voting for, and Commissioners Cox and Clark voting against.

After discussion, Commissioners White , Cox, and Smith voted for, and Commissioner Clark voted against.

Then Commissioner Keith Clark asked that they vote again, and make it unanimous. So motion carried, with all voting for.

Motion made by Commissioner Cox to remove bo-mag from table. Commissioner White seconded. Motion failed with Commissioner Cox and White voting for; Commissioner Clark and Smith against.

Judge Larry Hyden advised the Commissioners Court of the current situation regarding bo-mag lease, and has stated to the best of his ability the statue of government of same. He stated upon being advised, it was majority opinion of court to leave motion tabled pending further study.

Motion made by Commissioner Cox, seconded by Commissioner Clark, that meeting adjourn. Motion carried.

CALLED MEETING: 1:30 P.M.

At this called meeting, John Payne, with T.A.C. was present, to explain our County Insurance:

Judge Hyden recommends County stay with Deep East Texas Workers' Compensation another year due to their submitting low bid of \$60,669.56. Other bids received - T.A.C. - \$86,136.00, and Texas Political Subdivision, Joe Max Green - \$94,499.00.

Motion made by Commissioner Chester cox to forego Crime Coverage Insurance. Commissioner Lynn Smith seconded, and motion carried.

Commissioner Cox made motion, which was seconded by Commissioner Clark, to authorize Judge Hyden to make decision on Public Officials Liability Insurance. Motion carried. Cost: \$2,921.00.

Law Inforcement Liability - No Punitive Damages. Cost \$11,583.00. Motion by Commissioner Cox, seconded by Commissioner Clark, to accept. Motion carried.

Auto Liability - Commissioner Cox made motion to accept Option A, with O deductable, Cost: \$7,736.00 per year. Commissioner Smith seconded, and motion carried.

Auto Physical Damage - commissioner Smith made the motion to accept option C - \$1,000.00 deductable - Cost: \$10,919.00. commissioner Cox seconded, and motion carried.

General Liability - Commissioner Cox made motion to accept Option C - \$10,000.00- Cost: \$9,287.00. Commissioner Clark seconded, and motion carried.

Property Coverage - Motion made by Commissioner Smith to accept option A - \$1,000.00 deductable; Cost: \$6,208.00. commissioner Cox seconded, and motion carried.

This is a total cost of \$48,654.00. \$40,000.00 is budgeted for this coverage. Deficit in actual cost above what is budgeted will be split equally between the four precincts. Motion made by Commissioner Clark and seconded by Commissioner Cox. Motion carried. Meeting adjourned.


