Brother Clarence Howell led the Court in prayer.

The reading of the minutes was waived.

Agenda item # 16-Cliff Cummings - Mr. Cummings told the Court that he feels that he is being discriminated against and that it has gotten to the point of endangering lives. He stated that the way the ^{emergency} calls are being handled is not fair to all legally insured and licensed wrecker services. He stated that there is also a problem with abandoned cars and boats. They are supposed to be handed over to the sheriff's Dept. for public auction. He does not remember a public auction being held on any vehicle. Any excess money over what the wrecker service is due goes to the County. He said that he realizes that there is a new sheriff and he has to be given a chance to get on top of all the rules and regulations. He stated that he has not been able to speak with Sheriff Bradberry in person and very little over the phone. Sheriff Bradberry was not present at the meeting at this time. The Court was informed that Sheriff Bradberry was on his way to the Court meeting. When Sheriff Bradberry arrived at the meeting there was more discussion with Mr. Cummings. Sheriff Bradberry told Mr. Cummings that the Commissioner's Court is not his boss and ask if he and his son would sit down with him to work the matter out. No action was taken by the Court.

Agenda item # 2-Speed limit & name-Mill Creek Road Pct.3- Commissioner White made a motion to officially name the road that is running in front of Mill Creek Grocery in Brookeland "Mill Creek Road". Commissioner Clark Seconded. Commissioners White and Clark voted for with Commissioners Cox and Smith voting against. Judge Hyden voted for to break the tie.Motion carried.

Second motion - Commissioner White made a motion that a speed limit of 15 miles per hour be posted on Mill Creek Road. Commissioner Clark seconded. All voted for. Motion carried.

Agenda item # 3-Road Base Material was deleted.

Agenda item #4 Delta Heights Road & Speed Limit- Commissioner White Made a motion to set a speed limit of 15 miles per hour. Commissioner Clark seconded. All voted for. Motion carried.

Agenda item # 5- Morris Road- Speed Limit & Name - Commissioner White made a motion to table the naming of the road until the next agenda. Commissioner Clark seconded. All voted for. Motion carried.

Commissioner White made a motion to set a 15 mile per hour speed limit on the road known now as the Sharkey Morris road. Commissioner Clark seconded. All voted for. Motion carried.

1st. bid quote: Texas Political Subdivision Workman's Compensation Joint Ins. Fund, submitted by Joe Max Green Ins. Agency, for \$94,499.00.

2nd. bid quote: Texas Association of Counties for \$86,136.00.

3rd. bid quote: Deep E. Tx. Self Ins. Fund through DETCOG, who is our current carrier, \$60, 669.56. Commissioner Smith Made a motion to stay with the present carrier which is Deep E. Tx. Self Ins. Fund for the amount of \$60, 669.56. Commissioner Clark seconded. All voted for. Motion carried.

Agenda item # 13- Court Cost - Teen Court - This is the cost of Court that will be charged. Judge Hyden made a motion for acknowledging and approving the charges for Court fees in the County's Teen Court. Commissioner Smith seconded. All voted for. Motion carried. See attached exhibit.

Agenda item # 14-IWC- Solid Waste sites 888, 889, 1360, 1667

Judge Hyden offered a motion to make the letter from the Texas Water Commission a part of the Commissioner Court minutes that this Court acknowledges receipt of the letter dated April 19, 1993 with regard to closing the waste sites located through out the County and move that the County Judge be authorized to notify the Texas Water Commission that we intend to close our existing land fills as so identified by numbers no later than July 31, 1993. Commissioner Cox seconded. All voted for. Motion carried.

Judge Hyden offered a motion that the County Judge make available and post notice for public inspection of Subtitle D requirements as submitted to us through the EPA and the Texas Water Commission. For anyone to have access to that and be able to study it. Commissioner Cox seconded. All voted for. Motion carried.

Agenda item # 10-Fuller Gravel Lease Agreement- Commissioner Clark made a motion to approve the amendments and additions to the original surface mineral lease agreement as reflected. Commissioner White seconded. All voted for. Motion carried. Copy of contract to be attached as soon as signed.

Agenda item # 12- County Hotel/Motel Tax- No action was taken.

Agenda item # 17- Receive & Open Bids for Sheriff's Dept. Vehicle-

Two bids were received: First bid is from Tipton Ford in Nacogdoches for 13,300.00 per unit for a total of \$26,600.00 for 2 units. Second bid is from Hemphill Motor Company for \$13,882.50 per unit for a total of \$27,765.00 for 2 units. Commissioner White made a motion to accept the bid from Tipton Ford. Commissioner Clark seconded. Commissioners White and Clark voted for with Commissioner Smith voting against and Commissioner Cox abstained. Judge Hyden voted for. Motion carried. Judge Hyden offered a motion to the Court that they approve the issuance of a time warrant in the amount of and not to exceed \$26,600.00. That this Court bind future Courts to the establishment of a tax rate sufficient to pay the ^{Interest 000-10-11} principle and establish a sinking fund of minimum of 2% the payment of ^{Principle 000} interest thereon. Said time warrant is due and payable in principle and interest no later than December 31, 1993. Commissioner Clark seconded. All voted for. Motion carried.

Court took a 5 minute break.

Court reconvened at 10:40 A.M.

The agenda was waived for John Worsham and James White with Timberlane Subdivision. The property owners would like for the Court to approve the new deed restrictions for their subdivision. The Court had approved their earlier restrictions. Judge Hyden ask that they leave the papers with him to be read over and to be put on the next agenda for approval.

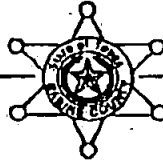

COSTS AND FEES FOR TEEN COURT

Teen Court Program (Art. 45.55 CCP)

A defendant who is under the age of 18 or enrolled full time in an accredited secondary school on a program leading towards a high school diploma and is charged with any Class C misdemeanor may take a teen court program approved by the court if he has not completed a teen court program in the two years preceding the date that the alleged offense occurred. The court may require a fee not to exceed \$10.00. Fee is not refundable.

Fees to be collected under the Teen Court Program.

For a misdemeanor punishable by a fine only where the penalty range does not exceed \$500.

Grandfathered Sites Status

Dear Judge Hyden:

The purpose of this letter is to advise you of the upcoming EPA's Subtitle D regulations, as well as the status of currently "grandfathered sites" under these new rules.

The Texas Water Commission (TWC) published State Subtitle D rules in the Texas Register on March 9, 1993. Copies of these rules can be obtained by contacting the Texas Register at (512) 463-5561. We expect these rules, which will go into effect on October 9, 1993, to be finalized and approved by the Commissioners sometime in May of this year.

Your sites, as described above, have been identified as "grandfathered sites" pursuant to 31 Texas Administrative Code (TAC) Section (§) 330.51. It is the TWC's intention to provide you with authorization to continue operating if you comply with the new Subtitle D requirements. To continue operating, you must perform the following:

1. Comply with all applicable Subtitle D requirements by October 9, 1993; and
2. Submit new or revised Site Development Plans and Site Operating Plans which demonstrate compliance with Subtitle D by April 9, 1994.

It will not be necessary to submit permit or amendment applications to comply with upgraded requirements of the new rules, if the capacity and size of your landfills are not increased.



If you determine that you wish to close your facilities, and if you complete final covers on the landfills by October 9, 1993, then the TWC current regulations on final covers and post-closure care and maintenance apply. Please be reminded that you must notify the TWC in writing of your plans for closure.

If you have not completed your final covers and closures by October 9, 1993, then you must comply with the proposed rules found in 31 TAC §330.252 - Closure Requirements for Municipal Solid Waste Landfill Facility Units or Facilities That Receive Waste on or after October 9, 1991, But Stop Receiving Waste prior to October 9, 1993. These proposed rules require an installation of final covers, described in 31 TAC §330.253, which shall be completed within 180 days of the last receipt of waste. If the final cover installations are not completed within 180 days from your landfills' last receipt of waste, then the landfills will be subject to all of the requirements for post-closure care and maintenance pursuant to the Subtitle D regulations. It is important that you evaluate your time schedule for closures and completion of covers. You must be aware that on October 9, 1993, the requirements for Subtitle D covers become effective.

The TWC staff would be happy to meet with you to discuss your requirements as they pertain particularly to your facilities. If you have any questions concerning what you must do to continue operations, please contact Susan Ham Janek, P.E. at (512) 908-7764. If you need further information concerning closure requirements for your landfills, please contact Michael Graeber, P.E. at (512) 908-6671. Again, our staff would welcome a meeting with you to discuss any of the new requirements if you need further guidance.


WHEREAS, Sabine County is in need of funds to purchase "Bulk Tanks" for the purpose of collecting used oil; and

WHEREAS, DETCOG has funds available up to a maximum per entity of \$4,648.00, therefore;


