Bro. Clarence Howell led the opening prayer.

Agenda items #'s 2,3 and 4 No action taken. These are to be on the August 9th agenda.

Agenda item #6 Close Road by Fairdale Church- No action taken. To be advertised in the paper on the closing of the road. To be on the August 9th agenda.

Agenda item #7 Commissioner Smith made the motion to accept the Election Judges and Alternates recommended by the County Clerk's office. Commissioner White second. All voted for. Motion carried. See attached exhibit.

Agenda item #8 Policy/Procedures Manual No changes were made.

Agenda item #9 Solid Waste Commissioner White made a motion to keep the dumps open until August 31, 1993. Motion died for lack of a second. No further action was taken.

Agenda item #10 Texas Dept. of Transportation Judge Hyden sat in on the Court meeting for a few minutes while on recess from Criminal Court. Judge Hyden made the motion to keep the Road & Bridge fee at \$5.00 for vehicle registration. Commissioner Clark second. All voted for. Motion carried.

Agenda item #11 Two bids were received on the red 1984 Oldsmobile. Bid #1 from John Ellender, Jr. for \$150.00 and bid #2 from Ronnie Hobbs for \$207.50. Commissioner Smith made a motion to reject both bids and re-advertise and to add that bids under \$500.00 would not be accepted. Commissioner White second. All voted for. Motion carried.

One bid was received on the tanks for used oil. The bid was from Fibrex in the amount of \$1,945.00 for a 465 gallon white used oil container. Commissioner Smith made a motion to table action until the next Court meeting. Commissioner White second. All voted for.

Agenda item #5 Commissioner Clark made a motion to hire Jim Campbell for the position of peace officer for solid waste and heavy equipment permitting. Commissioner Cox second. After a discussion, Commissioner Cox withdrew his second and Commissioner Clark withdrew the motion. Commissioner Cox made a motion to hire a part time officer. Commissioner Smith second. All voted for. Motion carried.

Court recessed until 1:00 P.M.

Court was called back to order and Judge Hyden resumed his position as Judge of the Court.

Agenda item #5 Commissioner White made a motion to advertise for a part time deputy. Motion was denied by Judge Hyden. No action was taken by the Court. There will be a called meeting on Monday August 2nd and Sheriff Bradberry will be asked to be present at that meeting to give his recommendation for the part time deputy.

Commissioner Smith made a motion to remove the bid from Fibrex from the table. Commissioner Cox second. All voted for. Judge Hyden made the motion to reject the bid from Fibrex and to re-advertise for bids. Commissioner Clark second. All voted for.

Court recessed for 5 minutes.

Court reconvened.

Commissioner Smith made a motion to pay accounts and salaries. Commissioner Clark second. All voted for.

In regular business, Commissioner Clark made a motion to approve the Resolution of Appointment of County Designee for Judge John L. Hyden and Commissioner Lynn Smith as alternate representative. Commissioner Smith second. All voted for. Final approval is to be made on August 2, 1993 in a called meeting.

Minutes of the previous Commissioner Court were approved as read.

Commissioner Clark made a motion to adjourn. Judge Hyden stated that the meeting was adjourned.
