# 6 - Commissioner Chester Cox gave report on appointment of 9 1 1 representatives. He also gave report concerning meeting tomorrow at 1:00 P. M., as well as other operating policies.

Agenda items - next meeting: Amendments to 911 operating policies; 911 resolution - approval by Court.

Motion made by Commissioner Keith Clark, seconded by Commissioner Chester Cox, to approve names presented for appointment. Motion carried. See attached list.

**WHEREAS**, the Commissioners Court wishes to recognize the historical significance of the Town of Milam and the many contributions of its citizens;


