At 3:38 p.m. the Commissioners' Court went into executive session.


At 4:07 p.m. the Commissioners' Court came back into the called meeting.

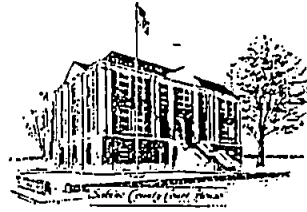

STATEMENT REGARDING KENNETH WHITE
AND APPOINTMENT OF CAROLYN WHITE AS COMMISSIONER, PCT. #3

The loss of Commissioner Kenneth White is a tragedy. His service to Sabine County and to the citizens of Precinct #3 can be best described as caring, committed, hard-working and concerned. He will be sorely missed by those he served and those of us who had the privilege to work with him.

Upon the loss of a County Commissioner it is the responsibility of the County Judge to name their replacement. It is never an easy decision and many things must be considered. It is my decided opinion that Ms. Carolyn White should be appointed as Commissioner of Precinct #3, to serve until the next general election, (November, 1994). This decision was made easier by the overwhelming support, (approximately 500 individuals), evidenced in writing, telephone calls and individual conversations with our constituents in Precinct #3.

The responsibilities of a County Commissioner are enormous. The demands upon both their time and abilities are substantial. I would encourage those people of Precinct #3 who have indicated their support for Ms. White to be appointed their commissioner to show a great deal of patience and understanding, particularly during the first 30 - 60 days, while she is getting her feet on the ground. Myself and the other members of the Commissioners Court will certainly be as helpful as we can be. I request the community at large to help, aid and assist Ms. White in any way and at any time they can; be a positive, not a negative, influence.

The death of Commissioner Kenneth White was not only a personal loss to his family, but to me and his many other friends. We must, and we shall, accept God's will and move forward with our lives and the business of this county in a manner that respectfully continues and is reflective of the life and service of Kenneth White. I am persuaded he would have wanted it that way.
