

On December 28, 1993, the Sabine County Commissioners' Court met in a regular meeting. The following members were present:

Judge Hyden brought the meeting to order. Bro. Clarence Howell led the opening prayer.

Minutes of the December 13, 1993 regular meeting were read with Commissioner White making the motion to approve, Commissioner Clark second. All voted for. Motion carried.

Minutes of the December 20, 1993 special called meeting were read with Commissioner Clark making the motion to approve, Commissioner Cox second. All voted for. Motion carried.

In other general business Commissioner Cox informed the Court of a piece of property in Milam that he is checking on for Pct. #4 for a Pct. barn. It is owned by the state. No action was taken. Also in general business, Judge Hyden told the Court that there is a concern about the intersection of Hwy. 83 and Hwy. 87 in front of Dairy Queen. This is a very dangerous intersection. No action taken at this time.

Agenda item #2 Reports- Reports were given for the following offices: County Attorney, J. P. #2 pl. 1, J. P. #1 pl. 1, J. P. #1 pl. 2, County Clerk, Tax Assessor, Judge Hyden and Ingrid Morris with a 911 update. Tax Assessor Tammy Reeves, told the Court that Mrs. Gwen Best had volunteered to do the comparison of the Counties voter files with the State's files. This has been a very valuable service to her office and that Mrs. Best should be recognized. Almost 6900 names had to be compared within a 2 week period so that the new voter registration cards could go out on time. Judge Hyden told the Court that he plans to compensate Mrs. Best for her travel time. Mrs. Reeves also ask the Commissioners to give her office a list of the people that they know are in the wrong voting pct. so that they could correct them.

Agenda item #3 Speed limit Delta Heights Road- No action taken. This is to be placed on the next regular Court agenda.

Court recessed from 9:50 until 10:20.

Agenda item #4 Pay Accounts and Salaries Judge Hyden made the motion to pay all accounts and salaries upon the signing or initialing of these District Court bills: Carl Birdwell \$1800.00; Dr. Jerry Landrum \$3,409.60; Dr. Curtis Wills \$840.00; Dr. Joseph Carte \$818.75; investigator \$195.00. Commissioner Clark second the motion. All voted for. Motion carried.

Judge Hyden told the Court that he will swear Janice McDaniel in as County Clerk, January 1, 1994 at 9:00 A.M., but there will be a formal swearing in on January 6, 1994 at 12:00 noon.


Commissioner Cox made the motion to adjourn. Commissioner Smith second. Meeting adjourned.
