

June 27, 1994, Sabine County Commissioners' Court met in a regular meeting. The following members were present:

Judge Hyden brought the meeting to order at 8:31 A.M. Bro. Clarence Howell led the Court in prayer.

Commissioner Cox has to leave the meeting at 9:30 A.M. this morning.

Agenda item #9- Establish County Fee/Vehicle Registration

Commissioner Cox made a motion to raise the County fee for vehicle registration from \$5.00 to \$10.00. Commissioner Clark seconded. All voted for. Motion carried.

Agenda item #12-Advertise for Sale of Surplus Equipment

Judge Hyden made the motion to advertise for bids for a shop built LoBoy trailer for Pct. #4. Commissioner Clark seconded. All voted for. Motion carried.

Agenda item #11-Barbara Bozeman

Mrs. Bozeman had presented a petition to Judge Hyden asking the Court to place speed limit signs on each road that leads from Hwy. 184 and 96 and to order the installation of the signs. Also to establish a speed limit of 25 MPH for all County roads located in what was the city limits of Bronson, Tx.

Commissioner White made the motion to establish a speed limit of 25 MPH for all County roads located in what was the city limits of Bronson, Tx.. Commissioner Clark seconded. All voted for. Motion carried.

Commissioner White's second motion- Approve the placement of speed limit signs on County roads (1 for each road) that leads from HWY. 184 and 96. Commissioner Clark seconded. All voted for. Motion carried.

Judge Hyden made the motion that the Commissioner of Pct. #3 may proceed with the installation of these signs as the Commissioner sees fit and money will permit. Commissioner Clark seconded. All voted for. Motion carried. See attached exhibit.

Agenda item #4- Open Bids Computer/Computer Software - Tax Office

One bid was received from Business Records Corporation for I B M System 36 or AS/400 Application Software System - 36 month lease contract is \$820.00 month; 60 month lease contract is \$710.00 month.

One bid was received from Pritchard & Abbott, Inc. for an AS400 Hardware and Software Support - Monthly rental \$600.00; 36 month lease purchase \$700.00 month.

Judge Hyden made a motion to accept the bid of Pritchard & Abbott on the lease purchase. Commissioner Clark seconded. All voted for. Motion carried. See attached exhibit.

Court recessed at 9:00 A.M.

Court reconvened at 9:07 A.M.

Back to agenda item #4-

Judge Hyden made a motion that the Commussioners' Court enter into the agreement contract to purchase the AS400 and associated software and services provided by Pritchard & Abbott dated June 27, 1994 with the first payment being due August of 1994. Commissioner Clark seconded. All voted for. Motion carried.

Agenda item #8- Purchase Rock Separating Machine

Judge Hyden made a motion that the County go out for bids for a rock separating/crusher equipment. Commissioner Cox seconded. Judge Hyden amended his motion by adding the words: as soon as specifications have been developed. Commissioner Clark seconded the amendment. All voted for. Motion carried. Motion now reads that the County will go out for bids on rock separator/crusher equipment as soon as specifications have been developed. Commissioner Cox seconded the amended motion. All voted for. Motion carried.

Agenda item #10- Appointment to DETCOG Board

Commissioner Smith made the motion that Judge Hyden be appointed to the DETCOG Board as the representative for Sabine County. Commissioner Cox seconded. All voted for. Motion carried. See attached exhibit.

Agenda item #13- Pay Accounts and Salaries

Commissioner Smith made the motion to pay accounts and salaries. Commissioner White seconded. All voted for. Motion carried.

Agenda item #6- Stock Ordinance

Judge Hyden made the motion that the County consider changes to its current stock ordinance. Commissioner Cox seconded. After discussion, Judge Hyden recinded his prior motion. Judge Hyden offered the following as a Resolution of the Court: It is the consensus of the Commissioners' Court that the enforcement of the stock ordinance should be within the pervue of the County Sheriff and that the authority to enforce the ordinance is hereby placed with the Sheriff. Further, the Sheriff shall be deligent in his actions regarding the apprehension of stray animals both in selection of individuals to catch and pen the animals and recooping cost incurred from the owners of said animals when such expense is incurred repeatedly. Further, any and all decisions regarding the above should be vested in the Sheriff who is responsible and accountable for the enforcement of the ordinance. Judge Hyden stated this is in the form of a motion. Commissioner White seconded. All voted for. Motion carried.

As a record of the Court, at 9:40 A.M. Commissioner Cox has been excused from the meeting. Four members still remain thereby constituting a quorum.

Agenda item #7-Thomas Johnson Voting Box

Will Smith informed the Court that the November General election would not be affected, but that they are working on finding another location for future elections to be held. He askthat it be on the next regular meeting of the Commissioners' Court.

Agenda item #5-Solid Waste

Commissioner White made a motion for an ordiance in Resolution form that would require the covering of any waste that is hauled by commerical haulers. Commissioner Smith seconded.

Court recessed at 9:55 A.M.

Court reconvened at 10:05 A.M.

Due to the fact that prior authority has been given Commissioner White withdrew her motion. Commissioner Smith withdrew his second. No further action was taken.

Agenda item #3-Public Hearing RE: 911-B Addressing, Road Names

Court entered into this public hearing at 10:05 A.M.. Also , the Judge announced the public hearing at the Courthouse door. No comments were made on this hearing. Judge Hyden closed the public meeting at 10:10 A.M.

Court entered back into regular meeting.

There was more discussion on the solid waste issue. No action was taken.

Under General Business- Commissioner Smith made the motion to approve the minutes of the June 13 and June 15 meetings as read with the correction of retired Judge Roy Fillyaw to Leroy Fillyaw. Commissioner Clark seconded. All voted for. Motion carried.

Judge Hyden made the motion that monthly reports from the County Clerk; Tax Assessor/Collector; JP#1 Pl. 1; JP#1 Pl.2; JP#2 Pl.1 be accepted. Monthly report from County Attorney be relected pending further review. Commissioner Clark seconded. All voted for. Motion carried.

Commissioner Clark made the motion to adjourn. Commissioner White seconded. Meeting adjourned.
