Agenda item #5- Off Road System Bridges

Commissioner Smith made the motion in the form of a Resolution to give Court approval to go forward with this project of the bridge on Bo Rig Read and ask for the State to give their assistance. Judge Hyden seconded the motion. All voted for. Motion carried.

Agenda items 8 & 9- George Hanks Road -- Kenneth Smith

The following people gave testimony concerning the road in question: George Hanks; Henry Hanks; Virgil Hussey; Kenneth Smith; Ernestine Smith; Eugene Tatom and David Grant with Temple-Inland. Mr. Hanks is wanting the road known as the "Neely Whitehead Road" declared a public road or a County road. This road and a Temple-Inland road are the only roads to Mr. Hank's property. The Temple-Inland road is about impassable when it rains and the "Neely Whitehead Road" has fence across it where it crosses Kenneth Smith's property. According to testimony given, the road was used by the public but was fenced and abandoned sometime in the latter 1940's or early 1950's.

Court recessed for a short break.

Court reconvened at 9:43 A.M.

More testimony was given at this time. Judge Hyden stated that if the road was a public road, meaning that the road is owned by the land owners and is only in trust by the County, the County does not actually have title to the road. Then it still is a public road unless the road has been continually fenced for a period of 20 years or more, then that constitutes abandonment by the County, whether there was formal action taken by the County or not. Then it is no longer a public road and not a County road either. The Court is going to have to base its decision on the statutes of this state. The Court will take it under advisement and will render a decision at a time that is not yet determined and that he willadvise each of the parties when it will be. No action was taken at this time. 
